How to Use This Roadmap

Use this roadmap to guide your progress and keep you moving toward graduation.

- ☒ **Meet with your advisor each term** to monitor your progress, review requirements (including foreign language), and address concerns early.
- ☒ **Review course requirements before registering** to ensure you meet all requirements and stay on track for graduation.
- ☒ **Maintain your eligibility** by meeting GPA and course completion requirements.
- ☒ **Stay on schedule** to avoid delays and excess credit hours that may not be covered by financial aid.

About the Program

The Associate in Arts (A.A.) degree is specifically intended to meet the requirements of students interested in transferring to one of Florida's many public colleges or universities or continuing to pursue a four-year bachelor's degree at FSCJ. The program aligns general education and elective coursework with common prerequisite requirements for upper-division study and is intended to support a smooth transition into a related bachelor's degree.

Students who have not met the **foreign language requirement** must complete a sequence of two college-credit courses in the same foreign language. These courses may be applied toward elective credit.

This transfer major roadmap requires a **minimum of 60 credit hours**, including general education and elective coursework. **General education courses** are completed across five liberal arts discipline areas, with specific course requirements outlined on the A.A. program catalog page. **Elective coursework** is selected based on the intended transfer major and may include prerequisite courses required by transfer institutions.

Total credit hours and course selections may vary based on a student's transfer institution and academic plan. Students are strongly encouraged to consult an advisor to ensure appropriate course selection and timely progress toward transfer. Course availability and term offerings are subject to change. Refer to the course schedule for current offerings.

Minimum Grade Requirements

A minimum grade of **C or higher** is required in courses used to satisfy the following:

- ☐ General education coursework
- ☐ Civic literacy requirement coursework
- ☐ Foreign language coursework

Stay on Track

In order to be awarded the associate in arts degree, students must have met the following requirements:

- ☐ Students must fulfill the specific program requirements as outlined in the Florida State College at Jacksonville Catalog.
- ☐ Earned a cumulative grade point average of 2.0 (C) on a 4.0 scale at Florida State College at Jacksonville in courses eligible toward the associate in arts degree program. (A.A. Florida State College at Jacksonville GPA).
- ☐ Earned an all-college cumulative grade point average of 2.0 (C) on a 4.0 scale on all courses attempted. This requirement includes Florida State College at Jacksonville college-credit semester hours and transferred credits (excluding developmental education) in lower division courses.
- ☐ Earned a grade of at least a C in each course used to satisfy the five General Education Requirements areas: I Communication, II Mathematics, III Humanities, IV Natural Sciences and V Social and Behavioral Sciences.
- ☐ Completed at least 25 percent of credit semester hours required for the degree at Florida State College at Jacksonville. Credit by examination and credit for prior learning do not count toward this residency requirement.
- ☐ Completed 60 semester hours of college credit work as follows:
 - ☐ General Education Requirements (36 semester hours) set forth in the general education requirements of this catalog.
 - ☐ Major elective prerequisites (24 semester hours) set forth in the major prerequisites section of this catalog.
- ☐ Demonstrated competency in a foreign language in accordance with Florida Statute 1007.25. Pursuant to guidelines set in Florida Statute 1007.262, competency is demonstrated by foreign language proficiency (at the intermediate level) equivalent to 2 years in high school or a sequence of two college credit courses in a single foreign language.
- ☐ Demonstrated competency in civic literacy in accordance with s. 1007.25, Florida Statutes (F.S.), and State Board of Education Rule 6A-10.02413, Florida Administrative Code (F.A.C.). Pursuant to guidelines established by Senate Bill 1108, competency is demonstrated by completion of one of three civic literacy courses (AMH 2010, AMH 2020 or POS 2041) with a grade of C or higher AND by achievement of the standard score on a state-approved assessment.
- ☐ Students must have fulfilled all financial obligations to the College before they may graduate.
