### What are the Requirements for Adult Education ESOL Classes?

- Must be 16 years of age or older(underage documentation required)
- · Bring your Florida driver's license or other valid identification document
- Provide immigration/citizenship documents:
  - U.S. Citizens (including Puerto Ricans): U.S. Passport or naturalization document
  - o Permanent Residents: Valid permanent resident card,
     temporary card, or passport stamped "Temporary I-551
  - o I-94 or USCIS approval letter stamped: Asylum Granted, Paroled, or Refugee
  - o Valid Visa or passport stamp
  - o I-797C USCIS approval letter showing application to apply or change status
  - o Employment authorization card

All Visa types <u>except</u> B1/B2 Tourist Visas and F-1 International Student Visas are accepted.

Please check with an advisor about scheduling procedures for CASAS pre-testing once you have received your FSCJ User ID.
