CALL TO ORDER:

College President John Avendano, Ph.D. and Committee Chair Hunt Hawkins called the Finance and Audit Committee meeting to order at 10:45 a.m. and welcomed those in attendance.

<u>INFORMATION /</u> <u>DISCUSSION:</u>

I. Review of Recent FSCJ Financial Audit:

Vice President of Finance & Administration Dr. Wanda Ford and Controller Lindsey Thomas provided an overview of the recent FSCJ Financial Audit for fiscal year ending June 30, 2022. The Auditor General reviewed the College's financial statements. They found those were presented fairly and there were no deficiencies in internal controls over financial reporting. There were no instances of non-compliance. Net position increased due to indirect cost of HEERF funds collected. Con Ed energy agreement was paid off to save \$1M annually until conclusion of agreement (2037).

II. Discussion of Interim Financial Statement: Vice President Ford and Associate Vice President for Administrative Services Steve Stanford provided an overview of the Interim Financial Statement as of February 28, 2023. Revenue is still down due to the decrease in enrollment for the year. Summer enrollment is up 2.4%. By restructuring various departments and using salary savings realized through cuts on 50 vacant positions, the College will be able to use these funds to address increases in utilities, costs of goods and services and salary inequities. Expenses have increased with the Criminal Justice Center, Commercial Vehicle Driving Program and dual enrollment. The Nursing Program has expanded to the Deerwood and Nassau Centers.

Due to FTE dropping this year, Fund Balance may drop to 5% allowable reserves. As in prior years, the College will submit a spending plan to include funds designated for hurricane insurance deductibles or other capital costs.

III. Discussion of 2023 – 2024 Budget:

Vice President Ford and Associate Vice President Stanford provided a review of the proposed allocation of additional recurring state funding. For the upcoming budget, the College projects receiving a state allocation that is between the amount included in the proposed House and Senate bills. President Avendano discussed the difference in the two bills. The House bill is using the Council of Presidents' new fund model while the Senate bill is basing projections on how the colleges were funded in the past. The College is projecting an increase in health care insurance, faculty/staff pay, and minimum wage. The College is conducting an analysis related to wage compression.

IV. Discussion
Regarding
Land/Property Sale:

President Avendano provided an overview of the potential sale of the Main Street Building Complex. Interest was expressed in the past by Groundworks to use as office space for free. The College obtained an independent property appraisal of the parcel. JWB Real Estate Capital, LLC will present to the DBOT at the upcoming workshop the proposed plan for the property. The sale of the property would allow the College to recover value in assets it no longer has the intentions of utilizing, and redirect resources to other capital projects.

NEXT MEETING:

The next meeting of the Finance & Audit Committee is scheduled for Tuesday, May 16, 2023 at the College's Administrative Offices as part of the DBOT Deep Dive Budget Workshop. The Committee will meet at noon in Board Room 405.

President Avendano shared with the Board information relating to FSCJ DBOT, Board Chair Michael Bell:

- Chair Bell was featured in the March 23, 2023 edition of *The Yulee News*.
- He congratulated Chair Bell on the wonderful article written on the insight/perspective of Wildlight and FSCJ.
- He thanked Chair Bell for his recent attendance at FSCJ's Senior Take Over Day at the Betty P. Cook Nassau Center.

Legislative Update:

President Avendano provided the Board with information relating to the Legislative Update:

- The Association of Florida Colleges (AFC) and The Florida College System Council of Presidents (COP) conducted a joint meeting in Tallahassee on March 23 and 24, 2023. He thanked Trustees Hawkins, Odom and McGehee for attending.
- He thanked FSCJ's Director of Government and Community Relations Taylor Mejia and The Southern Group for their coordination and support. The group was visited by a number of legislators and the Commissioner throughout the day.
- Proposals from the House and the Senate appear to be very favorable for the State College System.
- The ask from the COP was for \$150 million in new program funding around the new budget funding model along with moving State College System employees to the University Health Care Program.

- It appears the COP will be successful in receiving additional funding; however, the health insurance idea may need to wait another year.
- The COP also has four projects for the College in their asks. These include the Criminal Justice Center and Fire Science Burn Building and the Health Careers expansion in the Governor's budget, and there is delegation support for the Veterans Center and Careers Connection Center.
- He thanked Director Mejia for her due diligence and updates.

Commencement Update:

President Avendano provided the Board with information relating to the Commencement Update:

- The College community is looking forward to the 2023 FSCJ Commencement Ceremony on Thursday, May 11 at VyStar Veterans Memorial Arena.
- Planning is well underway to make the event memorable for FSCJ students and their loved ones. Trustees will soon receive communications with specific details on timing, parking and more. He encouraged the Board to join him at the arena.
- Over the past couple of weeks, the College has held Grad Fest events across the different campus/center locations, where FSCJ's soon-to-be graduates were able to pick up their caps, gowns, honors cords and more.
- He thanked everyone who participated. The College had more than 1,000 graduates at all the events.

University of Florida Update:

President Avendano shared with the Board information relating to the University of Florida's Update:

- As an update on the University of Florida (UF) expansion into downtown Jacksonville, the project has passed through the City and the first \$20 million of \$50 million City dollars was approved.
- UF is working to raise \$50 million from private supporters and the bill has been proposed for an additional \$100 million through the state legislature.
- The programs UF plan to offer at the downtown location will be at the graduate level so there will be no direct competition with FSCJ's work. UF's goal is to serve 1,000 students once they are at full capacity.
- At this time, there is still no confirmation on the location UF intends to use.

Community Partner Event Recap:

President Avendano shared with the Board information relating to the Community Partner Event Recap:

- On March 31, 2023, the College held the FSCJ Connections: Community Partner Event at Downtown Campus, inviting representatives from the community, including nonprofits, financial institutions and workforce preparation partners.
- This was a great opportunity to share some of the College's recent and upcoming highlights while building stronger connections for further engagement.
- There were over 50 attendees at the event.
- Participants were able to learn about some of FSCJ's academic programs and resources the College has in place to support students.
- The intent of the program was to build stronger connections with FSCJ's partners.

FSCJ Golf Tournament:

President Avendano shared with the Board information relating to the FSCJ Golf Tournament:

- The College is excited for the FSCJ Golf Classic, presented by First Florida Credit Union, on Monday, April 24, 2023, at Queen's Harbour Yacht and Country Club.
- The event will once again benefit FSCJ's BlueWave Athletics program.
- There are a variety of ways Trustees can participate even if, you are unable to join us.
- He shared with Trustees if they would like to learn more, please reach out to him directly or FSCJ's Executive Director of the Foundation Cleve Warren.

- As an update on the institution's ten-year SACSCOC reaffirmation process, FSCJ's compliance report was submitted and the College awaits the results of the off-site review, which should come later this month or early May 2023.
- The SACSCOC VP virtual advisory visit is scheduled for May 31, 2023.
- The response reports and Quality Enhancement Plan (QEP) are due to the on-site committee on September 11, 2023. Their visit will take place from October 23-26, 2023.
- The College will need to coordinate with a few of the Trustees for the visits.
- In June 2024, the College will receive the review and decision by the SACSCOC Board of Trustees.

Data Dashboard:

President Avendano shared with the Board information relating to the April 2023 Data Dashboard/high-level view of the institutional data sets:

- Spring Term College Credit Enrollment:
 - o Down -0.2% credit hours compared to spring 2022.

- o Represents 100.4% of overall enrollment for spring 2022.
- O When compared to spring 2021, college credit enrollment is down -13,627 credit hours.
- Summer Term College Credit Enrollment:
 - O Up +2.3% credit hours compared to summer 2022.
 - Represents 65.1% of overall enrollment for summer 2022.
 - O When compared to summer 2021, college credit enrollment is down -3,027 credit hours.
- Finance Report shows actual revenues and expenditures compared to budget for the period ending February 28, 2023 and February 28, 2022.
- Grants Report:

REPORT OF THE FINANCE & AUDIT COMMITTEE COMMITTEE CHAIR, TRUSTEE HUNT HAWKINS APRIL 11, 2023

Vice President of Finance and Administration and Controller Lindsey Thomas provided an overview of the annual audit of the College's financial statements for the fiscal year ended June 30, 2022. The audit did not identify any deficiencies in internal control over financial reporting that the auditors consider to be material weaknesses. In addition, the results of the tests disclosed no instances of noncompliance or other matters that are required to be reported under Government Auditing Standards.

As presented in the 2021-22 financial statements, the College's assets and deferred outflows of resources totaled \$311 million and liabilities and deferred inflows of resources totaled \$115 million. The year-end balance of \$195 million represents an increase of \$15 million in net position.

Vice President Ford and Associate Vice President for Administrative Services Steve Stanford discussed the Interim Financial Statements for the quarter ended February 28, 2023. Currently, student fees are down approximately \$1.4 million due to the decrease in enrollment. HEERF funds are being used to cover tuition and fee revenue loss through FY 2022-23. The expiration date for these funds is June 30, 2023. State appropriations, contracts and grants, and auxiliary revenues are trending as anticipated. Salary expenses are trending \$3 million less than budgeted. The reduction in salary expenses will be used to address the increase in utilities and the cost of goods and services.

Vice President Ford and Associate Vice President Stanford provided a review of the proposed allocation of additional recurring state funding which could range from \$4.3 million to \$7.7 million. There is also a possibility of \$2.1 million for expansion of the nursing program. If realized, the additional state allocations, the strategies implemented to reduce salary expenditures, as well as the stabilizing of enrollment should allow the College to consistently maintain a balanced budget in the absence of HEERF funds.

College President John Avendano, Ph.D. provided an overview of the potential sale of the Main Street Building Complex. The College obtained an independent property appraisal that included an estimated value of \$4.6 million which is also the offering price from JWB Real Estate Capital, LLC. The future sale would allow the College to recover value in assets it no longer has the intentions of utilizing, and redirect resources to other capital projects. Any future plans for the proceeds will be brought to the Board for approval, once determined.

President Avendano also provided an update on the plans for the UF Downtown Campus.

- 1. Work on the Campaign Readiness Study with Erin Phillips; Gonser Gerber, continues to march forward to an August/September 2023 completion deadline.
- 2. Erin's task over the next several months will include:
 - a) Completion of the Case Statement.
 - b) Interview approximately 50–60 donors and community stakeholders for perceptions and interest in giving to the Capital Campaign.
 - c) Advise the talent search for additions to the Foundation Development Team.
 - d) Conduct training on vetting and the on-boarding of new Foundation Board members.
- Prospect Management, donor mining, and donor cultivation have been major components of the training provided by Gonser Gerber to staff and Foundation Board members. The effect has led to more effective stewardship practices with Foundation donors and constituent groups.
- 4. In the wake of the Silicon Valley Bank collapse, and the bank's place as a facilitator of cash transactions in private equity and venture capital markets, the Foundation has been very timely in sharing situational information with its members about the impact/or non-impact to its investment holdings, and in including them in virtual updates from its investment advisors; the Commonfund.
- 5. As of February 28, 2023, the aggregate market value of the investment portfolio was \$66,442,873. Earnings from the portfolio provide the source to fund scholarships and programs at the College, and total funding for staff and operations of the Foundation.
- 6. The next "Regular Meeting" of the Foundation Board of Directors (FBOD) will be held on Thursday, May 18, 2023; a little out of sequence with its normal calendar quarter month meeting rotation, adjusted to accommodate some board governance training to be conducted by Gonser Gerber.
- 7. At its May 2023 meeting, the Foundation Board looks to review and approve its Annual Audit with recommendation from the Finance and Audit Committee, and on approval will then forward the audit on to the FSCJ District Board of Trustee for approval.

Re: April 2023 Career Employees' Council Report

Chair Bell and Trustees:

Thank you for this opportunity to share with you the most recent and numerous milestones achieved by the Career Employees' Council (CEC). In my report for you, I am pleased to share that the Council is currently focused on examining many ways in which it may improve in, and sustain, operational effectiveness when serving as a collaborative problem-solving partner to any/all actionable data in support of the success of students, College, and staff. In this vein, the milestones shared in this report highlight our focus on:

Operational Effectiveness

Firstly, the Council has been very active in improving its governance of policies, actions, and agility in handling affairs — as well as newly developing objective criteria on measures of success. In the broad interest of facilitating improved synergy with all stakeholders, on November 9, 2022, the Council's Bylaws Committee was charged with completing the contemporizing of the Council's Bylaws (last revised in 2015). The Bylaws Revision was completed on March 3, 2023, and is now available to upcoming Representatives' vote for adoption. In culmination, the overarching *Bylaws Revision Project* policies are designed to:

- Enhance our recruiting success and team compositions so that organizational alignments,
 paired with individual(s) strengths, experience, and interests may bolster service work efforts
- Promote leadership, team and community-building, via integral subcommittee service work
- Provide an improved framework in which our Representatives may engage, organize, execute, monitor, and evaluate initiatives
- Enhance the quality of communications, information, and support response time for our Collegewide stakeholders

The CEC Board expresses great appreciation (in no particular order) to Audrey Antee, Vanessa Gordon, Brian Keane, Lisa Moore, and Shannon Oliver for the invaluable assistance and progress on this vital project.

Secondly, specific to enhancing vision planning, service capacity, and transparency of Council operations, the *CEC SharePoint Website* (https://fscj.sharepoint.com/teams/CareerEmployeeCouncil) was redeveloped and re-released on January 22, 2023, as a forward-facing intranet communication centerpiece for "All Employees." Within, added emphasis was placed on Customer Focus, "Ask for Help" Resources (to help bridge any gaps in communication and responsiveness), Community Engagement, and Project Management. Future action plans include exploring additional solutions

that may provide employees greater access to our Campus/Center Representatives, Team Charter frameworks, as well as providing our Publicity Committee with communication outlets dedicated to employee welcoming, recognition, and recruitment. The Council worked diligently to provide this content within a short span of build time (under one-month) – on which, the Council is most grateful for the continued Web Development and Publicity volunteerism.

Employment Enhancements

For employment enhancement initiatives – as per Council's Bylaws Mission to "Conduct ongoing studies and make recommendations on policies and procedures for, but not limited to" employment policies and procedures – late last year, the Council was aligned with the Administrative and Professional Collaborative to form the *APC & CEC Joint Committee for Employee Enhancements*. This Joint Committee then aligned with members of the Executive Leadership Team to form the broader *Interest-Based Problem-Solving (IBPS) Committee*. In progression, I am pleased to report that the team has been working, with great unity, on The CARE Project Discussion. As of February 23, 2022, the team has progressed to IBPS Phase 5 (of 6), "Brainstorm Multiple Solutions" – with Phase 6, "Reach Consensus on Preferred Options" on the near horizon. The Council wishes to express gratitude to President Avendano, Dr. Wanda Ford, Mark Lacey for the opportunity to assist on this task, and to Audrey Antee for seamless facilitation.

Fundraising and Professional Development

On the Fundraising and Professional Development milestones, the Council executed its annual holiday season *Poinsettia and Ferns Sale Event* on December 9, 2022, to raise proceeds for the upcoming *Spring Book Scholarship Awards* – in support of FSCJ Employees' Education and Professional Development ambitions. The Council acknowledges its signature Fundraising Event would not be possible without the exceptional planning and execution of the event by Tamera Meyer, Camilla Collins, and Cynthia Motzny. Equal appreciation is expressed to the many invaluable Career Employee Representatives that personally delivered the goods to our charitable, collegial patrons. As a result of the fundraiser, our Book Scholarship Awards Committee, chaired by Stephanie Castro, was able to extend the awards to 4 recipients – an increase of one over last year.

Community Engagement

Additionally, regarding community engagement service projects, Council members aligned with members of the Association of Florida Colleges, and the Administrative and Professional Collaborative (APC) to organize and provide employees, on December 2, 2022, the *FSCJ Winter Gala*: A Holiday Season Community Engagement event involving a full dining experience (3-course meal), a FSCJ Jazz Band musical performance, a DJ and social dancing segment, and an employee recognition segment to top it off. The Council commends Bryan Stewart for leading the well-orchestrated event planning and for the opportunity to contribute to what was referred to as a "well-received and enjoyable" community engagement event by some of those that attended.

Lastly, on January 17, 2023, the Council joined members of the APC and Faculty to form the **FSCJ Employee Recreational Sports Planning Committee** with APC Chair, Kerry Roth, serving as Lead. In alignment with the broader Visionary Impact Plan 2.1.2, Strategic Initiative specified as, "Create affinity groups and mentoring opportunities for current faculty and staff," the Council received clearance from VIP 2.0 oversight to begin developing affinity group proposals within Employee

Governance Groups. In this community engagement case, Career Employee affinity groups may center on the interests of "Physical Fitness," and "Health and Wellness." This Committee has submitted its proposed programing to the broader HR Health and Wellness Committee for consideration and partnership, and it hopes to deliver on employee engagement activities during the upcoming summer semester – when facilities are more readily available for employee use.

In summation, the Council is committed to the Mission, Vision, and Values of FSCJ. It is fully committed to ensuring that students have a positive and successful student experience. We look forward to continued collaboration as we continue to make FSCJ a great place for our students to achieve their educational goals and for our current and future employees to achieve their professional goals.

On behalf of the Career Employees, we express our appreciation to the District Board of Trustees for your time, effort, and support that you bring to the College community, staff, and students.

Chair Bell and Fellow Trustees:

Enrollment is at the forefront of our faculty members' minds. I know this is a common refrain in my recent letters, and I know this is also a concern for many at the institution. I am also aware that this is a nationwide issue that is rooted in past bad practices as well as changing concepts related to the value of a higher education. When I look at the recent article from the Hechinger Report (Jon Marcus, "The reckoning is here': more than a third of community college students have vanished," The Hechinger Report [April 3, 2024] https://hechingerreport.org/the-reckoning-is-here-more-than-a-third-of-community-college-students-have-vanished/) I can see descriptions of some of the same complaints I have heard from my students over the past decade. Institutional disorganization, which for us can lead students chasing answers across campuses and across Jacksonville, was a key feature of how this article describes the failures of institutions to help students succeed. We have gotten better in this regard, there is no doubt. And we are getting much better at getting financial aid into the pockets of students sooner by modifying policies such as our "never attended" policy process. These changes will have slow repercussions over the next few years that we hope will help rebuild our relationship with the community and potential students.

However, our institutional failures and occasional incompetence in the past do not fully explain where we are now. For one, we are demonstrably better in our processes now than we were several years ago and more efficient in getting students through the enrollment pipeline. We are seeing success rates in online tick up slightly with new pedagogical practices. Through work that helps us analyze and understand the cultural, social, economic heterogeneity of our community and our student body, we are designing better course materials and practices to help us reach wider populations. There seem to be other forces at work against us.

One is the economic reality our students face. Online education is getting cheaper, even those programs offered by larger universities. Our students are also well aware of the job market and find it impossible to pass up job opportunities that pay relatively high salaries — without requiring a degree. Even the 'gig' economy has had an impact, pulling our students away from their studies and into an immediate source of cash income. The economic calculus for the immediate future does not always add up in our favor.

This economic calculus adds to a growing disenchantment with higher education as a whole. If I could even map the reasons for this, they would be far too complicated to mention here. The economy is part of this for sure. The growing recognition of the costs of higher education on the future of students who need to take out loans to finish their degree is a component as well. And unfortunately, the horror stories we hear reported in the news are not extreme and rare cases, but rather much closer to the norm. And while we cannot change the national discourse around higher education, we can focus on bettering the lives of the students who come to us and on promoting certain qualities of higher education that are both pragmatic and idealistic.

Half of America's Hispanic students and forty percent of America's Black students attend community colleges and state colleges. I know anecdotally that one of the main reasons for this is cost and convenience. These students choose colleges not out of a desire to avoid universities or some disdain for them, but because the costs of attendance are too high. We also know that 4 out of 5 students who attend community colleges and state colleges intend to transfer to a four year bachelor's program – yet only 1 in 6 do so.

I think these facts give us direction. We need to make sure our students feel as though they are not second class students – in other words, we need to think of them as curious adult intellectuals intent on achieving academic ideals. We also need to make sure students are supported through to the end of their careers and give them constant direction on either finishing and transferring to a BA or BS degree, including into our own BS programs, or finding employment. Our Guided Pathways work will help with this but it needs more vigorous attention and support – specifically in the classroom and in our academic support services. Faculty need to understand the career arc of students and work with them holistically – including understanding how the abstract values of higher education can and do help people in their work and their personal lives. Our disorganized academic structure in the AA degree is perhaps a hindrance to this and has eroded the community-oriented nature of campuses.

However, a bigger difficulty is that students do not stay on one campus for all of their classes — they are forced to move from campus to campus to find the courses they need at convenient times and days. We need to help them understand the value of higher education as something that is not transactional, and forcing them to fit into our disjointed schedule does not help with that process. We do not often see students more than once or twice a week on campus because of their schedules. This leaves us little chance to interact with them outside of the classroom or to talk about their future plans. Working on improving our scheduling process and perhaps addressing other workload issues will help strengthen our rapport with students and hopefully improve their outcomes.

Pedagogically I think our moves to humanize our syllabi and our online pedagogy — making the former more readable and understandable and promoting more direct engagement with the faculty member in the latter — put us on track to improve outcomes through our teaching. We must also look into what students need in order to be successful in their work and private lives. I am an academic idealist as anyone will tell you. I feel as though academics has made the human race better. But I also know it is not feasible for many of our students to move on to a university degree.

Reasonably, they look to the working world to provide for them and their futures. And yes, basic mathematical and writing skills will improve their prospects. However, we cannot underplay the importance of reasoning, argumentation, empathy, moral and ethical responsibility, and other skills. And we should be promoting those skills as well.

Students need to learn how to be confronted with differing opinions on all manner of topics and how to integrate their own worldview with those of their fellows in the workforce. They need to learn how to reflect on their actions and even to reflect before acting — as well as understand their own fallibility. They need to be able to express ideas in a professional fashion, with careful attention to detail but also with an audience in mind. They need to learn how to analyze datasets; but they also need to learn about the empathy that makes great leaders and great entrepreneurs.

Businesses work by understanding the demands of the client and living up to unexpressed expectations. They need to interpret the minds and emotions of the customer. To this end, our students need to understand Kantian moral principles. They must be able to see human beings as ends in themselves, not as means to an end. This is what makes them successful in their work lives and in their private lives. Higher education promotes those skills, but I think we can try to do better and be more intentional, because a transactional mindset undermines that moral principle and undermines the communal ties that bind us together.

That concludes my report to the Board.

Re: April 2023 Student Government Association Report

Chair Bell and Trustees:

The Student Government Association (SGA) is the voice of the student body at Florida State College at Jacksonville (FSCJ). Please see the following updates and accomplishments for the period between February 2023 and April 2023.

Since the last report, the SGA has accomplished the following:

- Between February 21-22, 10 members of the SGA traveled to the Tallahassee Community College for the Florida College System Student Government Association (FCSSGA) Legislative Conference. The students attended professional development workshops and traveled to the Capitol building to meet with legislators regarding the bills that affect FSCJ students.
- On March 2, the International Club hosted the Carnival Brazilian Celebration at the Downtown Campus in the Art Gallery. The event provided Brazilian food, dancing, and activities for students and staff to enjoy.
- On March 4, the 56th Annual Talent & Variety Show was held at the Wilson Center. SGA members attended as well as participated as judges in the oldest tradition at the College.
- This spring, members of the SGA have been able to hear professors Dr. Paul McLester (January 31), Jannefer Rojas-Coleman (March 2), Jennifer Chase (March 21), Susan Amburgey (March 30), and Dr. David Purificato (April 6) give their Last Lecture presentations.
- During the months of March and April, the SGA hosted Spring Fling events at all of the campuses and centers. These events featured cookouts, games, music, and information tables with various student and community organizations to help celebrate the arrival of the spring season.
- Six members of the SGA attended the Student Activity and Service (A&S) Fee Committee Trainings on March 22 & 25. They will be joined by other student leaders in serving on the A&S Fee Committee and hearing funding proposals from various student clubs and areas of the College that receive A&S fee funding. The proposals will occur between April 4-7. After hearing the proposals, the committee will deliberate on how the funds will be disbursed for use during the 2023-2024 academic year.
- Between March 28 and April 7, members of the SGA participated in the Grad Fest Celebrations by cheering on and serving popcorn to students as they arrived to pick up their Commencement regalia as well learn about FSCJ baccalaureate programs and alumni information.
- Between April 14-15, 11 members of the SGA will travel to the Daytona State College for the FCSSGA End of the Year Conference. The students will attend professional development workshops, vote on the officers to serve on next year's State and Region Executive Boards, submit FSCJ's entry into the FCSSGA Scrapbook Competition, and network with other students from across the state.

On behalf of the student body, we extend our deepest gratitude to the District Board of Trustees and College President Dr. John Avendano for continuing to provide the SGA the opportunity to share updates and accomplishments of our students. Thank you for your time and all that you do for the students of FSCJ.

Subject: Administration: Comprehensive Safety Review for 2022-23

Meeting Date: June 13, 2023

RECOMMENDATION: It is recommended that the District Board of Trustees approve the College's Comprehensive Safety Review for fiscal year 2023. The full report will be available at the District Board of Trustees Meeting.

BACKGROUND: Pursuant to Florida Statute 1013.12 and the State Requirements for Educational Facilities, Chapter 5(1)(a)1 (SREF), each year the College is required to complete and submit to the Board for approval a Collegewide comprehensive safety inspection report listing safety code deficiencies. The review was conducted within the current fiscal year with a time span beginning in September 2022 and finished in March 2023. The review encompasses all buildings, rooms and grounds of the College Campuses and Centers. During the inspection, 767 safety deficiencies were identified. The report reflects that 751 of 767 reported deficiencies have been corrected. The College's Comprehensive Safety Review for 2022-23 includes the correction or anticipated correction date and actual or estimated cost for each item.

RATIONALE: Conducting an annual comprehensive safety review of all College facilities for fire safety, casualty and sanitation is required by Florida Statute and State Requirements for Educational Facilities. The review assures the Board is informed in a timely manner of all College safety deficiencies noted. None of the safety deficiencies noted are life-threatening deficiencies which, by statute, would require the Board to withdraw the facility from use until corrected.

FISCAL NOTES: The College has utilized its operational funds to correct all deficiencies identified during the annual comprehensive fire safety, casualty and sanitation review.

RECOMMENDATION: It is recommended that the District Board of Trustees authorize College administration to enter into a satisfactory construction contract in the amount not to exceed \$412,900 with ShayCore, LLC as the responsive low bidder meeting the construction documents for the North Campus Re-Paving & Criminal Justice Center Driving Course & Skills Pad.

BACKGROUND: Re-Paving of the North Campus loading dock service drives & Criminal Justice Center (CJC) Driving Course & Skills Pad was identified to be at end of life on the Deferred Maintenance Program 2020 submission for the Capital Improvement Plan (CIP) FY 2021-22. On October 26, 2022, a total amount of \$27,329,608 was awarded to FSCJ from the Florida Department of Education of the Federal American Rescue Plan (ARP) Act of 2021, Coronavirus State Fiscal Recovery Fund – Deferred Maintenance Program which includes \$2,104,704 designated for Critical Life Safety, Environmental Deficiencies under the Project Title Site Upgrades – Pavement for multiple buildings. The funding is to be fully obligated by December 31, 2024, and fully expended with all construction completed by December 31, 2026.

Faced with the challenges described above the College selected CPH Consulting LLC (Formerly known as CPH, Inc.) as the Engineer of Record for this project based on their extensive experience in civil engineering projects.

A formal Invitation to Bid solicitation was issued to 48 licensed paving and general contracting firms. As required by the State Requirements for Educational Facilities Section 4.1, the solicitation was also posted on the Florida's My Florida Market Place Bidding System and published in the Florida Times Union. Three firms submitted cost bids and two firms submitted No Bids on May 18, 2023. ShayCore, LLC is being recommended as the successful low bidder meeting the qualifications and contracting experience.

RATIONALE: Authorization to award this contract to the responsive low bidder meeting specifications is pursuant to State Board Rule 6A-14.0734 and will allow the project to proceed as scheduled.

FISCAL NOTES: The required funding will come from The State of Florida Department of Education Federal American Rescue Plan (ARP) Act of 2021, Coronavirus State Fiscal Recovery Fund – Deferred Maintenance Program.

On October 26, 2022 a total amount of \$27,329,608 was awarded to FSCJ from the Florida Department of Education of the Federal American Rescue Plan (ARP) Act of 2021, Coronavirus State Fiscal Recovery Fund – Deferred Maintenance Program which includes \$13,730,406 designated for Environmental Deficiencies under the Project Title Building Envelope Upgrades and Study (Roof Replacement, Curtain Wall Removal, Replacement, ReRoof) for multiple buildings. The funding is to be fully obligated by December 31, 2024, and fully expended with all construction completed by December 31, 2026.

Faced with the challenges described above, the College selected Akel Logan & Shafer PA the Architect of Record for this project based on their extensive experience in roofing projects.

A formal Invitation to Bid solicitation was issued to 79 licensed general and roofing contracting firms. As required by the State Requirements for Educational Facilities Section 4.1, the solicitation was published in the Florida Times Union and also posted on the Florida's My Florida Market Place Bidding System. On April 20, 2023, seven firms' submissions were received, four bidders were not qualified and deemed non responsive and three cost bids were opened. BBG Contracting Group, Inc. is being recommended as the successful low bidder meeting the qualifications and contracting experience.

RATIONALE: Authorization to award this contract to the responsive low bidder meeting specifications is pursuant to State Board Rule 6A-14.0734 and will allow the project to proceed as scheduled.

FISCAL NOTES: The required funding will come from The State of Florida Department of Education Federal ARP Act of 2021, Coronavirus State Fiscal Recovery Fund – Deferred Maintenance Program.

On April 24, 2023, six firms' submissions were received. Three bidders were prequalified, one bidder was not qualified and deemed non responsive, and two no bids were received. Three cost bids were opened and one cost bid was deemed non responsive. Register Roofing and Sheet Metal, Inc. is being recommended as the successful low bidder meeting the qualifications and contracting experience.

RATIONALE: Authorization to award this contract to the responsive low bidder meeting specifications is pursuant to State Board Rule 6A-14.0734 and will allow the project to proceed as scheduled.

FISCAL NOTES: The required funding will come from The State of Florida Department of Education Federal ARP Act of 2021, Coronavirus State Fiscal Recovery Fund – Deferred Maintenance Program.

Subject: Human Resources: Florida College System Annual Equity Update Report
Meeting Date: June 13, 2023

RECOMMENDATION: It is recommended that the District Board of Trustees approve the submission of the College's 2022-2023 Annual Equity Update Report to the Florida Department of Education as required by Florida Statute.

BACKGROUND: The College is required annually to provide a status report of efforts made to comply with Florida Statutes as they relate to nondiscrimination and equal access to postsecondary education and employment. The Annual College Equity Update Report serves to document efforts by each college in the Florida College System to meet federal laws related to civil rights and nondiscrimination in the treatment and admission of students and employees. The Report includes a review of:

- Policies and Procedures that Prohibit Discrimination
- College Employment Equity Accountability Plan
- Strategies to Overcome Underrepresentation of Students
- Substitution Waivers for Admissions and Course Substitutions for Eligible Students with Disabilities
- Gender Equity in Athletics

Florida Department of Education (FLDOE) requires assurance of compliance with certain Federal laws that prohibit discrimination or denial of services based on race, color, national origin, gender or disability. Florida's public colleges are required, in part, to include in their reports plans to increase diversity among its students and employees, and to develop methods and strategies to increase the participation of students of a particular race, ethnicity, national origin, gender, disability, or marital status in programs and courses in which they may have been traditionally underrepresented.

A copy of the full Report has been provided to Trustees individually.

RATIONALE: The item is presented to inform the District Board of Trustees of the requirements of the Community College Educational Equity Act and to comply with the reporting requirements.

FISCAL NOTES: The item has no economic impact.

RECOMMENDATION: The annual financial audit for Florida State College at Jacksonville Foundation, Inc. for the fiscal year ended September 30, 2022, and the attached audit checklist, is submitted to the District Board of Trustees for review pursuant to F.S. 1004.70(6).

BACKGROUND: The Foundation must submit for review its annual financial audit to the Office of the Auditor General, the State Board of Education, and the Florida State College at Jacksonville District Board of Trustees within 9 months of its fiscal year end.

The audit was prepared by Dixon Hughes Goodman LLP in accordance with rules adopted by the Auditor General pursuant to s. 11.45(8). In the opinion of the auditor, "the annual financial audit of the Foundation presents fairly, in all material respects, the financial position of the Foundation as of September 30, 2022, and the changes in its financial position and its cash flows for the year then ended, in conformity with accounting principles generally accepted in the United States of America."

MANAGEMENT DISCUSSION AND ANALYSIS: The decrease in current assets in the current fiscal year is largely due to accounts receivable due from the College. At September 30, 2022 and 2021, accounts receivable due from the college totaled \$5,950,643 and \$11,627,991, respectively. Amounts due from the college are associated with unearned revenue from prepaid subscribers and advance ticket sales for the 2023 Artist Series season. The increase in current assets in the prior fiscal year is largely due to accounts receivable due from the College of \$11,627,991 associated with unearned revenue from prepaid subscribers and advance ticket sales for the 2022 Artist Series season.

The 15% decrease in investments from \$72.2 million to \$61.3 million is due largely to a decrease in the fair value of certain endowed assets during the year ended September 30, 2022, as was the 27% increase in investments from \$57 million to \$72.2 million was due largely to an increase in the fair value of certain endowed assets during the year ended September 30, 2021.

RATIONALE: Submission and review of the Foundation's annual financial audit and audit checklist to the District Board of Trustees follows F.S. 1004.70(6).

FISCAL NOTES: There is no fiscal impact to the College associated with acceptance of the audit.

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Florida State College at Jacksonville Foundation, Inc. (the "Foundation"), a direct-support organization and component unit of the Florida State College at Jacksonville, which comprise of the statements of net position as of September 30, 2022 and 2021, and the related statements of revenues, expenses and changes in net position, and cash flows for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly in all material respects, the financial position of the Foundation as of September 30, 2022 and 2021, and the changes in its revenues, expenses, and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS") and the standards applicable to financial audits contained in Government Auditing Standards, issued by the Comptroller General of the United States. Our responsibilities under those standards are further described in the Auditor's Responsibility for the Audit of the Financial Statements section of our report. We are required to be independent of the Foundation and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation of financial statements that are free of material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Foundation's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.



Auditor's Responsibility for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS and Government Auditing Standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS and Government Auditing Standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due
 to fraud or error, and design and perform audit procedures responsive to those risks. Such

- Obtain an understanding of internal control relevant to the audit in order to design audit

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

Required Supplementary Information

Accounting principles generally accepted in the United States of America require that management's discussion and analysis on pages 4 through 10 be presented to supplement the basic financial statements. Such information, although not a part of the basic financial statements, is required by the Governmental Accounting Standards Board who considers it to be an essential part of financial reporting for placing the basic financial statements in an appropriate operational, economic, or historical context. We have applied certain limited procedures to the required supplementary information in accordance with auditing standards generally accepted in the United States of America, which consisted of inquiries of management about the methods of preparing the information and comparing the information for consistency with management's responses to our inquiries, the basic financial statements, and other knowledge we obtained during our audit of the basic financial statement. We do not express an opinion or provide any assurance on the information because the limited procedures do not provide us with sufficient evidence to express an opinion or provide any assurance.



Report on Supplementary Information

Our audit was conducted for the purpose of forming an opinion on the basic financial statements of the Foundation taken as a whole. The accompanying schedule of expenditures of federal awards, as required by Title 2 U.S. Code of Federal Regulations ("CFR") Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards for the year ended September 30, 2022, is presented for purposes of additional analysis and is not a required part of the financial statements. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records to prepare the basic financial statements or to the basic financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. In our opinion, the information is fairly stated in all material respects in relation to the basic financial statements taken as a whole.

Other Reporting Required by Government Auditing Standards

In accordance with Government Auditing Standards, we have also issued our report dated May 18, 2023, on our consideration of the Foundation's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. The purpose of that report is to describe the scope of our testing of internal control over financial reporting and compliance and the results of that testing, and not to provide an opinion on internal control over financial reporting or on compliance. That report is an integral part of an audit performed in accordance with Government Auditing Standards in considering the Foundation's internal control over financial reporting and compliance.

Management's Discussion and Analysis

The Management's Discussion and Analysis ("MD&A") provides an overview of the financial position and activities of Florida State College at Jacksonville Foundation, Inc. (the "Foundation") for the years ended September 30, 2022 and 2021, and should be read in conjunction with the financial statements and related notes.

The Foundation is a direct-support organization and a component unit of Florida State College at Jacksonville (the "College"), a governmental agency. The Foundation's mission is to secure financial resources for Florida State College at Jacksonville to provide students in need access to an affordable, quality education and to enhance the lives and the economic development of Northeast Florida.

The Foundation's financial statements are presented on an accrual basis, which includes (1) assets and liabilities as current and noncurrent; (2) revenues and expenses as operating and non-operating; (3) the use of the direct method for the statement of cash flows; and (4) management's discussion and analysis of the financial results.

The MD&A focuses on current activities, resulting changes and currently known facts to provide the reader with an overall summary of the accompanying financial statements. It should be read in conjunction with the basic financial statements and accompanying notes.

Pursuant to GASB Statement No. 35, the Foundation's financial report consists of these basic financial statements:

- Statements of Net Position
- Statements of Revenues, Expenses, and Changes in Net Position
- Statements of Cash Flows
- Notes to Financial Statements

The \$3,609,697 in unearned ticket revenue for the Artist Series is a result of advance ticket sales for the upcoming 2023 season, which typically starts in November/December. These advance ticket sales speak to the high renewal rate of the Artist Series' annual subscribers and continued community interest in the various shows that are presented.

Cash contributions to the Foundation for the years ended September 30, 2022 and 2021, include major gifts greater than \$50,000 from donors such as Bank of America Foundation, Florida Blue Foundation, Fidelity Foundation, and PMK Foundation.

State of Florida Grant Programs (Dr. Philip Benjamin Matching). At September 30, 2022 and 2021, the Foundation had \$18.5 million and \$16.4 million, respectively, of state matching funds for eligible donations (which are temporarily suspended) that may be funded by the State at a future date.

First Generation Matching Grant Program provided additional scholarship funding. Approved by the Florida Legislature, the program provides state matching funds for unrestricted contributions received by the Foundation and dedicated for this purpose at the sole discretion of the Foundation. In fiscal year 2022, the Foundation received \$85,273 of private contributions and a 100% state match allotment on those funds. The primary purpose of the program is to provide scholarship opportunities to students who are first-generation college students in their family.

Statements of Net Position

The purpose of the Statements of Net Position is to present the Foundation's financial condition as of the end of the fiscal year. The Statements of Net Position will enable the reader to determine the Foundation's ability to continue its operations, amounts owed to vendors and creditors, and the assets that are available to pay expenditures of the Foundation.

The following represents a condensed statements of net position and the changes in the Foundation's assets, liabilities and net position:

Current assets

The decrease in current assets in the current fiscal year is largely due to accounts receivable due from the College. At September 30, 2022 and 2021, accounts receivable due from the college totaled \$5,950,643 and \$11,627,991, respectively. Amounts due from the college are associated with unearned revenue from prepaid subscribers and advance ticket sales for the 2023 Artist Series season.

The increase in current assets in the prior fiscal year is largely due to accounts receivable due from the College of \$11,627,991 associated with unearned revenue from prepaid subscribers and advance ticket sales for the 2022 Artist Series season.

Noncurrent assets

The 15% decrease in investments from \$72.2 million to \$61.3 million is due largely to a decrease in the fair value of certain endowed assets during the year ended September 30, 2022, as was the 27% increase in investments from \$57 million to \$72.2 million was due largely to an increase in the fair value of certain endowed assets during the year ended September 30, 2021. A more detailed breakdown of the Foundation's investments may be found in Notes 3, 4, 5, and 6 which are an integral part of these financial statements.

Liabilities

Total liabilities from the 2021 period to 2022 period decreased by 62%, from \$14.7 million to \$5 million and can be ascribed to an decrease in unearned pledge revenue. Total liabilities from the 2020 period to 2021 period increased by 47%, from \$9.9 million to \$14.7 million and can be largely ascribed to an increase in unearned ticket revenues associated with Artist Series' activities.

Net position

Net position at September 30, 2022 totaled \$66.9 million, a decrease of \$8.9 million, or 12% from total net position of \$75.9 million as of September 30, 2020.

Net position at September 30, 2021 totaled \$75.9 million, an increase of \$17.9 million, or 31% from total net position of \$58 million as of September 30, 2020. Net position consists of two categories as follows:

- 1. Restricted assets consist of the following:
 - Restricted by donors expendable represents amounts which are available for spending in accordance with the donor's specified criteria; and
 - Quasi endowments expendable represents assets restricted by the Foundation as matching funds for the Dr. Philip Benjamin Matching Grant Program and for the Foundation's operational needs; and
 - Permanent endowments nonexpendable represents the Foundation's restricted nonexpendable endowment funds which are required to be held in perpetuity.
- 2. Unrestricted assets represent amounts available to the Foundation for operational purposes in support of its mission.

Statements of Revenues, Expenses, and Changes in Net Position

The purpose of the Statements of Revenues, Expenses and Changes in Net Position is to provide the details of the operating and non-operating activities for the fiscal year. This includes the revenues displayed by major source, expenses, and gains and losses received or incurred by the Foundation.

The Statements of Revenues, Expenses, and Changes in Net Position includes the following categories:

- Operating Revenues are revenues received from donor cash and noncash contributions, in- kind support from the College, grants and other program revenues.
- Operating Expenses represent expenses incurred for goods and services provided in return for the
 operating revenues to carry out the mission of the Foundation. Operating expenses include
 scholarships to College students, salaries and benefits, institutional and program support to the
 College, education programs, and management and general expenses supporting the Foundation
 operations, exclusive of Artist Series activities.
- Net Operating Income/(Loss) represents the amount of operating revenues in excess of the year's operating expenses and does not include non-operating revenue.
- Artist Series activities represents revenues and expenses related to the Foundation's Artist Series
 events, shows and other activities.
- Non-operating Revenues represents amounts received from sources for which no services are provided by the Foundation, e.g., investment income from endowed and other investments.
- Additions to Endowments represent contributions received for permanent endowments.

The change in net position is the result of the fiscal year's excess of or lack of excess of revenues over expenses.

In summary, the Foundation is structured as follows:

Fund development

Solicitation of donors for endowed and non-endowed contributions for scholarships, programs, and other needs of the College.

Foundation support

Financial accounting, investment administration and operations support for the Foundation. The allocation of funds allocations is also determined therein.

Artist Series

Production of Broadway shows and performing arts programs from which the Foundation receives the net operating income at the end of the Series season.

Non-operating revenues (expenses)

Amounts received from sources for which no services are provided by the Foundation, e.g., investment income from endowed and other investments.

Additions to endowments

Contributions received for permanent endowments.

The Statement of Revenues, Expenses, and Changes in Net Position is presented as part of the basic financial statements. For the years ended September 30, 2022 and 2021, the Foundation's increase (decrease) in net position before contributions to endowments were \$(9.1) million and \$17.7 million, respectively, primarily due to the increase in market values for investments.

Fund development

For the years ended September 30, 2022 and 2021, the Foundation received major gifts from donors such as Bank of America Foundation, Florida Blue Foundation, Fidelity Foundation, and PMK Foundation.

Artist Series

The Artist Series had \$3,609,697 in advanced ticket sales for the 2023 season, a decrease of \$8,599,892 from the previous year end 2022 season.

The Artist Series had \$12,209,589 in advanced ticket sales for the 2022 season, an increase of \$4,209,650 from the previous year end 2021 season.

Florida State College at Jacksonville Foundation, Inc. Management's Discussion and Analysis

The Artist Series is a self-sustaining auxiliary service and, as such, receives no in-kind support from the College for any expenses, including the salaries and benefits of its staff. The net income of \$3,163,063 for the year ended September 30, 2022, resulted in an amount due from the College which is remitted to the Foundation from the College's resources.

The Artist Series is a self-sustaining auxiliary service and, as such, receives no in-kind support from the College for any expenses, including the salaries and benefits of its staff. The net income of \$429,485 for the year ended September 30, 2021, resulted in an amount due from the College which is remitted to the Foundation from the College's resources.

Non-operating revenues and expenses

Year ended September 30, 2022

Non-operating revenues/expenses totaled a \$10.4 million net loss, which includes interest and dividend, net of investment fees loss of \$102,619. Investment losses of \$10.3 million are attributed primarily to market value depreciation in the Foundation's investment portfolio.

Year ended September 30, 2021

Non-operating revenues/expenses totaled a \$16 million net gain, which includes interest and dividend, net of investment fees loss of \$117,901. Investment gains of \$16.1 million are attributed primarily to market value appreciation in the Foundation's investment portfolio.

Additions to endowments

Year ended September 30, 2022

Permanent endowments. The Foundation received \$131,132 in donor contributions to its permanent endowments. There were no state matching funds received in fiscal 2022.

Year ended September 30, 2021

Permanent endowments. The Foundation received \$144,480 in donor contributions to its permanent endowments. There were no state matching funds received in fiscal 2021.

Statements of Cash Flows

The Statements of Cash Flows provides certain information about the Foundation's financial results by reporting the major sources and uses of cash and cash equivalents and indicates the cash provided by and used for operating, capital and related financing activities, and investing activities.

Operating Activities include funds received from private donors, projects, grants and other sources, and Artist Series activities and payments made to employees, suppliers for goods and services, and the College for programs, institutional and facilities support for Foundation operations.

Noncapital Financing Activities include funds received from donors for contributions to permanent endowments.

Investing Activities represent funds used to purchase investments and funds received from proceeds of investment sales, interest and dividends, and distributions from private equity funds.

Capital assets

The Foundation had no capital assets at September 30, 2022 or 2021.

Florida State College at Jacksonville Foundation, Inc. Management's Discussion and Analysis

Economic outlook

The financial position of the Foundation is directly affected by certain economic conditions of Jacksonville's local economy. Through private and corporate contributions, as well as net operating revenues from Artist Series activities, the Foundation is expected to be able to directly support Florida State College at Jacksonville's efforts to continue providing scholarship support to students, the development of new programs to meet the ever-changing needs of employers and provide a leadership role in educational and community services for Duval and Nassau counties in northeast Florida.

Requests for information

Notes to the Financial Statements

1. Nature of Organization and Summary of Significant Accounting Policies

The Florida State College at Jacksonville Foundation, Inc. (the "Foundation") is a not-for-profit corporation organized as a direct-support organization, as defined in Section 1004.70 of the Florida Statutes, and a component unit of the Florida State College at Jacksonville (the "College"). The Foundation provides financial support for the benefit of the students and programs of the College.

Revenue and support are received primarily from individuals and businesses, most of whom are located in northeast Florida. The Foundation also derives financial resources from the FSCJ Artist Series (the "Artist Series") program which operates as a fundraising component of the Foundation and College. The Artist Series is a presenter of performing arts events and shows in northeast Florida and supports the College's performing arts efforts including the Scholarship Endowment Fund. The Fund supports performing arts students, as well as other students, attending Florida State College at Jacksonville.

Basis of accounting

The financial statements of the Foundation have been prepared using the economic resources measurement focus and the accrual basis of accounting. Under this method, revenues are recorded when earned and expenses are recognized when they are incurred. The Foundation follows pronouncements issued by the Governmental Accounting Standards Board ("GASB"). GASB establishes standards for external financial reporting which includes a statement of net position, a statement of revenues, expenses and changes in net position, and a statement of cash flows using the direct method. These pronouncements also include a requirement that management provide a discussion and analysis of the basic financial statement and the classification of net position into three components – net investment in capital assets, restricted; and unrestricted. These classifications are defined as follows:

Net investment in capital assets

Capital assets, net of accumulated depreciation, reduced by outstanding balances of any debt that is attributable to those assets (currently not applicable to the Foundation).

Restricted

Consists of assets that have externally imposed constraints placed upon their use, either by donors or through laws, regulations, or restrictions imposed by law through constitutional provisions or enabling legislation, reduced by any liabilities to be paid from these assets as follows:

- Expendable net position that is subject to donor, grantor or other outside party restrictions as to
 use for the benefit of various programs at the College or Foundation, including the expendable
 portion of endowment funds;
- Nonexpendable net position representing the nonexpendable portion of endowment funds that are subject to donor, grantor or other outside party restrictions as to use for the benefit of various programs at the College or Foundation.

Unrestricted

Net position that does not meet the definition of "restricted" or "net investment in capital assets" and are available without restriction for carrying out the Foundation's objectives. Unrestricted net position may also be appropriated for specific purposes by action of the Foundation's Board of Directors.

Cash and cash equivalents

For purposes of the statement of cash flows, the Foundation considers all cash on hand, cash on deposit, and highly liquid investments with original maturities of three months or less to be cash and cash equivalents. At September 30, 2022 and 2021, unrestricted cash and cash equivalents included amounts on deposit with a commercial bank totaling \$4,134,752 and \$3,979,259 respectively, which are available for immediate withdrawal. Restricted cash and cash equivalents totaled \$659,558 and \$983,049 at September 30, 2022 and 2021, respectively, consisting of bank demand deposit accounts.

Custodial credit risk - deposits

Custodial credit risk for deposits is the risk that, in the event of the failure of a depository financial institution, the Foundation may not be able to recover its deposits. The Foundation periodically maintains public deposits in excess of the Federal Deposit Insurance Corporation. All such public deposits as defined by Chapter 280, Florida Statutes are placed in Qualified Public Depositories. The Foundation had \$4,050,617 and \$3,983,043 in excess of federally insured limits at September 30, 2022 and 2021, respectively. Management does not believe there is any significant credit risk relative to these deposits.

Investments

Investments are stated principally at fair value based on quoted market values. Private equity fund and other alternative investments are based on external valuation sources. Net realized and unrealized gains and losses are recognized in the accompanying statement of revenues, expenses, and changes in net position. Investments classified as noncurrent primarily represent the corpus of donor restricted contributions and amounts subject to other restrictions as well as investments not expected to be used during the Foundation's next fiscal year. The Foundation's intent is to hold its investments for the long term. However, the short-term operating needs of the Foundation may, at times, require the sale of a portion of these assets, subject to the approval of its Finance Committee from recommendation of the investment committee.

Unearned revenues - Artist Series

Unearned revenues primarily represent tickets sold in advance for Artist Series events and shows occurring after the statement of net position reporting date.

Contributions and pledges

The Foundation recognizes unrestricted contributions, including unconditional promises to give, as assets and revenues in the period received at fair values. Contributions are considered unrestricted unless their use is specifically restricted by the donor. Gifts of cash and other assets are reported as restricted support if their use is restricted by any outside party.

The Foundation receives pledges of financial support from corporations and individuals. Revenue is recognized when a pledge representing an unconditional promise to give is received and all eligibility requirements, including time requirements, have been met. In the absence of such a promise, revenue is recognized when the gift is received. In accordance with GASB Statement No. 33, "Accounting and Financial Reporting for Nonexchange Transactions", endowment pledges or other pledges restricted for use in future periods do not meet eligibility requirements and are not recorded until the related gift is received.

Donor-restricted endowments

Investment income, including unrealized appreciation and depreciation, is allocated to the restricted expendable account on a pro rata basis based on a 36-month average nonexpendable endowment balance. In accordance with state law, these funds are then available for expenditure, at 4% annually, when the specific donor criteria are met.

In the absence of donor stipulations or law to the contrary, losses on the investments of a donor-restricted endowment fund reduce restricted expendable net position to the extent that donor-imposed temporary restrictions on net appreciation of the fund have not been met before a loss occurs. Any remaining loss reduces unrestricted net position.

If losses reduce the assets of a donor-restricted endowment fund below the level required by the donor stipulations or law, gains that restore the fair value of the assets of the endowment fund to the required level are classified as increases in unrestricted net position.

After the fair value of the assets of the endowment fund equals the required level, gains that are restricted by the donor are classified as increases in restricted expendable net position or restricted nonexpendable net position, depending on the donor's restrictions.

Operating income

Operating revenues and expenses are those items resulting from providing services and producing and delivering goods and services. Revenues and expenses not meeting this definition are reported as non-operating revenues and expenses. Interest and dividends, net gains and losses on investments, and contributions received for endowments or from state matching funds are considered non-operating. When both restricted and unrestricted resources are available for use, the Foundation's policy is to use restricted resources first, then unrestricted resources as needed.

In-kind contributions

The College provides the Foundation with certain administrative and fiscal services, support personnel and staff, and office space at no cost. In addition, the College may incur expenses for the Artist Series performing arts events in excess of amounts reimbursed by the Foundation. Third parties, at times, may also contribute certain non-cash items for the benefit of the College. Such in-kind contributions are recorded at their estimated fair values both as revenues and expenses.

Real estate and artwork

Real estate and artwork are stated at cost on the date of purchase, or in the case of donated gifts, at their estimated fair value on the date of contribution. Changes in estimated fair value are recognized in the statement of changes in net position. Upon disposition, any related gain or loss is included in the change in net position.

Advertising and promotion

Advertising and promotion costs are primarily related to Artist Series shows and events. These costs are expensed as incurred. Advertising and promotion expense totaled \$71,991 and \$26,631 for the years ended September 30, 2022 and 2021.

Income taxes

The Foundation is a not-for-profit organization as described in Section 501(c)(3) of the Internal Revenue Code and is exempt from federal and state income taxes on related income pursuant to Section 501(a) of the Internal Revenue Code and Chapter 220.13 of the Florida Statutes, respectively. As such, only unrelated business income is subject to income tax.

Use of estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect (1) the reported amounts of assets and liabilities; (2) disclosure of contingent assets and liabilities at the date of the financial statement; and (3) the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Adoption of new accounting standards

The Foundation adopted new accounting guidance Governmental Accounting Standards Board Statement No. 87, Leases, which is a change in accounting principle that addresses accounting and financial reporting of leases. This statement addresses accounting and financial reporting for leases and requires the Foundation to recognize certain lease assets and liabilities for leases that previously were classified as operating leases and recognized as inflows of resources or outflows of resources based on the payment provisions of the contract. Under this statement, a lessee is required to recognize a lease liability and an intangible right to use the leased asset, and a lessor is required to recognize a lease receivable and a deferred inflow of resources, thereby enhancing the relevance and consistency of information about the Foundation's leasing activities. The Foundation adopted this standard as of October 1, 2021. The adoption of this standard does not impact the comparability of amounts reported in prior periods.

Subsequent events

The Foundation has evaluated the effect subsequent events would have on the financial statements through May 18, 2023, which is the date the financial statements were available to be issued.

Pledges receivable are recorded at net realizable value in accordance with GASB 33. Pledges receivable for amounts due in greater than one year from the reporting date have been discounted at 4.48% and 1.73% at September 30, 2022 and 2021, respectively. No allowance for uncollectible pledges was considered necessary at September 30, 2022 and 2021.

Five donors represented all of total pledges receivable at September 30, 2022. Eight donors represented all of total pledges receivable at September 30, 2021.

3. Investments

The Foundation's investments are recorded at fair value and consist of corporate bonds, U.S. government bonds and agency securities, equity mutual funds, fixed income mutual funds, money market funds, and private equity funds. Real estate and artwork available for sale are recorded at estimated fair values.

The estimated fair values of investments are based on valuations provided by external investment managers and consist of the following:

The Foundation had subscribed to a total capital commitment in private equity funds of \$11,150,000. Additional subscriptions increased total capital commitments to \$14,150,000 at September 30, 2022 and 2021. Cumulative capital calls totaled \$11,460,126 through September 30, 2022 (\$10,218,040 at September 30, 2021), leaving future capital commitments of \$2,689,874. Capital calls are due from time to time without notice in varying amounts. The Foundation generally expects to be able to meet its capital commitment obligations.

Interest rate risk

The Foundation's investment policy does not specifically limit debt obligation maturities. However, as a means of managing the Foundation's exposure to fair value losses arising from changes in interest rates, the policy provides for diversifying fixed-income investments among maturities according to interest rate prospects.

Credit risk

The Foundation's investment policy provides that no more than 15% of the corporate debt securities in the fixed-income portfolio may be rated below investment-grade.

Custodial credit risk

The Foundation's investment policy does not address custodial credit risk.

Concentration of credit risk

The Foundation's investment policy provides that the maximum amount invested in the securities of a single issuer may not exceed 5% of total investments. Securities issued by the United States government and its agencies are not subject to this limitation.

5. Fair Value of Financial Assets

The Foundation implemented GASB Statement No. 72, Fair Value Measurement and Application ("GASB 72"), effective July 1, 2015. GASB 72 establishes the accounting and financial reporting issues related to fair value measurements of investments. The Foundation's investments are reported at fair value, as defined under U.S. generally accepted accounting principles, which establishes a framework for measuring fair value and requires disclosures about fair value measurements. Accordingly, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

This standard also establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The Foundation has characterized its investments based on a three-level hierarchy to classify fair value measurements for disclosure purposes as follows:

- Level 1: Quoted prices are available in active markets for identical investments as of the reporting date.
- **Level 2:** Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third-party pricing services for identical or similar assets or liabilities.
- Level 3: Pricing inputs are unobservable for the investment and include situations where there is little, if any, market activity for the investment. The inputs into the determination of fair value require management judgment and estimation. Such investment valuations are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques.

Inputs broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. The Foundation uses the market approach valuation technique to value its investments.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the unobservable inputs. Prices for certain cash equivalents and investment securities, such as U.S. government bonds and agency securities, fixed income and equity mutual funds, and corporate bonds, are readily available in the active markets in which those securities are traded, and the resulting fair values are categorized as Level 1.

There is little or no observable market data for the prices of, private equity funds and artwork that are held by the Foundation. As a result, the fair values of these investments are categorized as Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value.

Commingled external investment pools

The Foundation's investments, including its endowments, in Commonfund are commingled external investment pools of assets in which investors own units of the fund, not the actual underlying securities in the fund. Each fund of the commingled investment pool allocates their assets among a select group of private investment funds. The funds pursue multiple strategies to diversify risks and reduce volatility. The Foundation records the fair value of its fund of the commingled funds' investments based on their proportionate share of the underlying fair value of the fund's net asset value as reported by the fund's investment manager. The Foundation's investments in the Commonfund external investment funds are categorized as Level 2 or 3 of the fair value hierarchy, dependent upon whether the inputs are observable or unobservable.

Private equity funds

Certain of the Foundation's endowment investments with Commonfund are also made in external private equity funds. Private equity funds are typically structured as closed-end, commitment-based investment funds in which the entity commits a specified amount of capital upon the fund's inception. Such funds generally do not provide for redemption options for investors nor permit subscriptions by new or existing investors. Accordingly, the interests in such private equity funds do not have an active market and are classified as Level 3 of the fair value hierarchy.

Artwork and real estate

Artwork and real estate are valued at their fair value on the date of donation. Since there is no active market for these investments, they are classified as Level 3 of the fair value hierarchy.

6. Funds Held as Agency Endowment

The Foundation holds certain funds as an agency endowment for the Prosperity Scholarship Fund, which provides scholarships to financially eligible students to attend college in northeast Florida. Scholarships to eligible students may be used at Florida State College at Jacksonville, University of North Florida, Jacksonville University, or Edward Waters College. Contributions to the Prosperity Scholarship Fund are permanently endowed and the investment earnings on the endowed account are used to fund the scholarships.

The Foundation recognizes an asset and liability which is measured at the fair value of the funds received from the donor. Distributions of cash for scholarships to specified third-party recipients are reported as decreases in the asset and related liability. Financial activity related to the fund is excluded from the Foundation's statements of revenues, expenses and changes in net position.

At September 30, 2022 and 2021, the balance in the Prosperity Scholarship Endowment account totaled \$93,275 and \$93,814, respectively, which is presented as a liability in the Foundation's statements of financial position. The following summarizes the fund's activity:

7. Shuttered Venue Operators Grant

During the years ending September 30, 2022 and 2021, the Foundation received grants of \$2,002,547 and \$4,005,095, respectively, under the Shuttered Venue Operators Grant program. This program was established by the Economic Aid to Hard-Hit Small Businesses, Nonprofits, and Venues Act, and amended by the American Rescue Plan Act. The grant provides emergency assistance to eligible venues affected by COVID-19. \$1,591,108 and \$1,868,235 was expended under this grant during the fiscal years ending September 30, 2022 and 2021, respectively.

8. State of Florida Matching of Private Contributions

The Foundation receives certain private contributions that were eligible to be matched, either all or in part, by the state of Florida College System. These matching funds are authorized by the Dr. Philip Benjamin Matching Grant Program for Community Colleges (Florida Statute 1011.85). For the year ended September 30, 2022, the Foundation submitted a certified appropriations request in the amount of \$1,611,695. The cumulative private contributions received during the period from February 2, 2007 to February 1, 2022 are as follows:

The Foundation's next appropriations request will be submitted upon request by the State.

Effective July 1, 2011, Senate Bill 2150 amended Florida Statute 1011.85 to temporarily suspend state matching funds for eligible donations received on or after June 30, 2011. As a result, the State of Florida Legislature did not appropriate funds for matching contributions for either of the years ended September 30, 2022 and 2021. Existing eligible donations remain eligible for future matching funds.

In addition to the above matching contributions, the state of Florida also appropriates certain nonrecurring general funds for scholarships to "first generation-in-college" students under the First Generation Matching Grant Program ("FGMG"). As of December 1, 2021 (for the year ended September 30, 2021), the Foundation had received \$85,273 of private contributions that were eligible for the FGMG match and had received 100% matching funds from the State of Florida by September 30, 2021.

10. Restricted Net Position

Expendable restricted net position is restricted for scholarships or other similar purposes and totaled \$6,040,196 and \$5,068,856 at September 30, 2022 and 2021, respectively.

Nonexpendable restricted net position (endowments) is donor-directed contributions restricted in perpetuity for scholarships, program instruction, and other similar purposes. Nonexpendable restricted net position totaled \$27,292,721 and \$33,464,631 at September 30, 2022 and 2021, respectively.

The Board of Trustees of the Foundation has interpreted the Florida Uniform Prudent Management of Institutional Funds Act ("FUPMIFA") as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment fund, absent donor stipulations to the contrary. As a result of this interpretation, the Foundation classifies as nonexpendable restricted net position: (a) the original value of the gift donated to the permanent endowment, (b) the original value of subsequent gifts to the permanent endowment, and (c) accumulations to the permanent endowment made in accordance with the direction of the applicable donor gift instrument at the time the accumulation is added to the fund.

The Foundation has adopted investment and spending policies for endowment assets that attempt to protect the principal of the fund, provide consistent long-term income returns and protect the Foundation against long-term inflation trends. To satisfy its long-term rate-of-return objectives, the Foundation relies on a total return strategy in which investment returns are achieved through both capital appreciation (realized and unrealized) and current yield (interest and dividends). The Foundation targets a diversified asset allocation that places a greater emphasis on equity-based investments to achieve its long-term return objectives within prudent risk constraints.

The Foundation limits spending on endowments to a maximum of 4% on endowed programs & scholarships spending and 1% for an administrative fee for a total of 5% annually of the most recent prior year-end endowment fund balances provided net earnings are available.

11. Related-Party Transactions

The College incurs certain other expenses on behalf of the Foundation. Other in-kind expenses provided by the College were \$32,317 for the year ended September 30, 2021. There were no in-kind expenses provided by the College for the year ended September 30, 2022.

In connection with an arrangement between the College and Foundation, the College also employs certain employees whose services are related to the Artist Series performing arts activities on behalf of the Foundation. Other costs and expenses related to the Artist Series may also be incurred by the College. Artist Series personnel costs totaled \$1,006,829 and \$957,779 for the years ended September 30, 2022 and 2021, respectively. None of these expenses were provided in-kind by the College. As of September 30, 2022 and 2021, amounts due to the College totaled \$1,430,223 and \$1,054,307, respectively.

At September 30, 2022, amounts due from the College totaled \$5,950,643 (\$11,627,991 as of September 30, 2021), primarily related to Artist Series ticket sales for shows and events that occurred during the reporting period and advance ticket sales collected by the College for shows to be performed after the statement of net position date. At the end of the College's fiscal June 30 reporting period, an accounting of the Artist Series revenue and expense activities is prepared by the College, and any residual funds, net of Artist Series event expenses paid by the College, are remitted to the Foundation.

12. Concentrations of Market, Credit and Currency Risks

The Foundation's investments are subject to various risk factors including market, credit, and currency risk. Investments are made in the United States and internationally and thus have concentrations in such regions. The fund's investments are also subject to the risk associated with investing in private equity securities. The investments in private equity securities are generally illiquid, and there can be no assurance that the fund will be able to realize the value of such investments in a timely manner. The Foundation had approximately 18% and 16% of its total portfolio invested in private equity funds at September 30, 2022 and 2021, respectively.

The funds are invested, for purposes of capital appreciation, in various underlying funds that vary by size, industry and geographical concentration. Investment performance of an industry sector in which the funds have a concentration of investments may have a significant impact on the performance of the fund.

The Foundation's invested funds also participate in assets and securities of non-U.S. issuers. Investments of this type may be subject to significant price fluctuations and above-average risk related to certain factors not typically associated with investing in U.S. securities, including risks relating to currency exchange matters, differences between the U.S. and foreign securities markets, and certain other economic and political risks with respect to such securities.

13. Commitments and Contingencies

Investment subscription agencies

The Foundation is party to various subscription agreements with a private equity fund manager which provide for capital contributions as requested by the funds. At September 30, 2022, future funding commitments totaled \$2,689,874 (\$3,931,960 at September 30, 2021).

Grantor agencies

At times, the Foundation may receive grants from various government agencies. Activities related to these grants are subject to audit by the regulatory funding authority. As a result, the Foundation may be contingently liable for reimbursement of funds received which may exceed reimbursable expenditures. The Foundation's management believes that the liability, if any, for any reimbursable amounts would not be material to the financial statement.

Notes to Schedule of Expenditures of Federal Awards

1. Basis of Presentation

The accompanying Schedule of Expenditures of Federal Awards (the "Schedule") includes the federal award activity of Florida State College at Jacksonville Foundation, Inc. (a not-for-profit organization) (the "Foundation") under programs of the federal government for the year ended September 30, 2022. The information in this Schedule is presented in accordance with the requirements of Title 2 U.S. Code of Federal Regulations (CRF) Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards ("Uniform Guidance"). Because the Schedule presents only a selected portion of the operations of the Foundation, it is not intended to and does not present the financial position, changes in net assets or cash flows of the Foundation. Therefore, some amounts presented in the Schedule may differ from amounts presented in the financial statements.

2. Summary of Significant Accounting Policies

Expenditures reported on the schedule are reported on the accrual basis of accounting. Such expenditures are recognized following the cost principles contained in the Uniform Guidance, wherein certain types of expenditures are not allowable or are limited as to reimbursement.

3. Indirect Cost Rate

The Foundation has elected not to use the 10% de minimus cost rate allowed under Uniform Guidance.

4. Contingency

The grant revenue amounts received and expensed are subject to audit and adjustment. If any expenditures are disallowed by the grantor as a result of such audit, any claim for reimbursement to the grantor would become a liability of the Foundation. In the opinion of management, all grant expenditures are in compliance with the terms of the grant agreements and applicable federal and state laws and regulations.

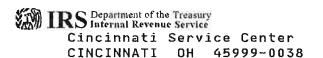

RECOMMENDATION: It is recommended that the District Board of Trustees approve the following Full Cost of Instruction Fee for students taking certain repeat course enrollments at Florida State College at Jacksonville per Florida Statute 1009.285 to be effective Fall Term 2023-24.

BACKGROUND: Florida Statute 1009.285, fees for repeated enrollment in college-credit courses, provides that students enrolled in the same undergraduate college-credit course more than twice shall pay tuition at 100 percent of the full cost of instruction. The statute further indicates that calculation of the full cost of instruction shall be based upon the system wide average of the prior year's cost of undergraduate programs for Florida College System institutions. The fees being presented for the Full Cost of Instruction are taken from the 2023 Florida College System Fact book, which is the most recent system information that is available.

RATIONALE: FSCJ will stay in compliance with Florida Statute 1009.285.

FISCAL NOTES: These fees are minimal and have historically only had small variances from year to year.

Subject: Finance: FSCJ ACCESS Program

Meeting Date: June 13, 2023

RECOMMENDATION: It is recommended that the District Board of Trustees approve the FSCJ ACCESS Program for Fall Term 2023, pursuant to Board Rule 6Hx7-4.19.

BACKGROUND: Florida Statutes 1009.22(9) Workforce education postsecondary student fees and 1009.23(12) Florida College System institution student fees allow the assessment of user fees. State Board Rule 6A-14.054(6), Student Fees, provides that each board of trustees may establish user fees in addition to tuition fees for services that incur unusual costs (specialized software and equipment, equipment and software maintenance, tests, kits, materials, insurance and others). These fees shall not exceed the cost of the goods or services provided and shall only be charged to students or agencies receiving those goods or services.

Florida Statutes allow inclusive access programs when there is documented evidence that the options reduce the cost of textbooks and course materials for students. Students enrolling in courses under this program benefit from significantly reduced textbook costs, as publishers are willing to sell for less when more students purchase the course materials. In most cases, the FSCJ ACCESS program utilizes electronic textbooks and online software. In accordance with Florida Statute 1004.085, Textbook and Instructional Materials Affordability, the FSCJ ACCESS program will utilize an opt-out approach, where students are charged for their books along with their tuition in the participating courses unless the student opts-out of the program. The additional course fees would be exactly what the bookstore provider charges for the course materials. Students enrolled in FSCJ ACCESS classes for Spring Term 2023 had total savings of \$760,043.

RATIONALE: The bookstore is able to provide course materials at lower costs due to volume and contractual arrangements with publishers that allow for the lowest cost for course materials when an inclusive access program is employed. This will ensure access to required resource material on the first day of classes to everyone in the FSCJ ACCESS class and will provide course materials at lower costs. This will guarantee the lowest cost to students because the College is able to secure a below competitive market rate for the material by purchasing in bulk.

FISCAL NOTES: This will have no net fiscal impact on the College.

This budget amendment decreases the Personnel Expenditure Budget by \$4,264,025 and the Current Expenditure Budget by \$400,000 due to a personnel reduction strategy and a large reduction in the College's delinquent student debt. This budget amendment increases the Capital Expenditure Budget by \$4,664,025. This will allow FSCJ to transfer some Capital Expenses to the Operating Expenditure Budget.

BACKGROUND: The Fiscal Year 2023-24 Capital Outlay Budget has been prepared in accordance with State Board of Education Rule 6A-14.0716, Florida Statutes 1001.64 and 1011.30, and Section 15.2 of the State Accounting Manual for Florida's Public Community Colleges.

RATIONALE: Florida Statute 235.18 and State Board of Education Rule 6A-14.0716(6) state that as part of the official budget, community college trustees shall adopt a capital outlay budget for the capital outlay needs of the college. The proposed budget encompasses projects to construct a Veterans' Center, to maintain facilities, and to renovate priority academic classrooms and labs. This budget shall designate the proposed capital outlay expenditures by project for the year from all fund sources.

FISCAL NOTES: The Fiscal Year 2023-24 Capital Outlay Budget is established at \$59,834,838.

Subject: Facilities: Approval of the Collegewide Master Plan

Meeting Date: June 13, 2023

RECOMMENDATION: It is recommended that the District Board of Trustees (DBOT) approve the Collegewide Master Plan (2023 to 2028). The full Master Plan will be available for review at the June 13, 2023 DBOT meeting.

BACKROUND: Per Florida Statute 1013.31 and District Board of Trustees Rule 6Hx7-8.8, the College shall prepare an Educational Plant Survey every five (5) years and a Facilities Master Plan must be included per State Requirements for Educational Facilities (SREF). The Collegewide Master Plan is a living document used as a planning tool throughout the year establishing short term, mid-term and long-term facilities planning and construction goals.

RATIONALE: Building on FSCJ's Visionary Impact Plan 2.0, the campus master plan will establish a framework for student, community and employee success that is context sensitive, technologically relevant and calibrated to the contemporary college experience. The Master Plan will be used as the basis for establishing both short-term and long-term projects for inclusion in the College's Educational Plant Survey. The plan provides for the phased development of the college over a period of twenty years based on projections for growth in Duval and Nassau Counties and the planned economic development by the City of Jacksonville Economic Development Commission.

The Master Plan addressed facility and academic requirements as well as future initiatives at all the campus locations. Projects are based on formal recommendations and will be included in the College's 2023 Five-Year Educational Plant Survey. The five-year survey consists of a facilities inventory of all spaces in the College and matches available space capacity against a five-year forecast of student enrollment growth for each campus.

In addition, substantiated space remodeling, facilities renovation needs and academic program requirements are evaluated for related design and construction costs. This documentation is included in the Master Plan and annual Capital Improvement Plan (CIP) that are submitted to the Florida Department of Education's (FDOE) Office of Educational Facilities for prioritization along with proposed projects from the other 27 colleges. The FDOE develops a consolidated list and presents it to the Legislature for potential Public Education Capital Outlay (PECO) funding.

FISCAL NOTES: The cost of the Master Plan was funded through an approved CIF appropriation.

RECOMMENDATION: It is recommended that the District Board of Trustees (DBOT) approve the College's annual Capital Improvement Plan (CIP) and Five-Year Educational Plant Survey (Survey) as summarized on the attached forms for submission to the Division of Colleges. A copy of the final CIP and Survey document will be available for review at the June 13, 2023 DBOT meeting.

BACKROUND: The CIP is an annual submission to the Division of Colleges, indicating the College's priorities for renovation, remodeling and new construction projects. These projects are based on recommendations included in the College's 2023 Five-Year Educational Plant Survey.

The Survey consists of a complete facilities inventory of all spaces in the College and matches the available space against a five-year forecast of student full-time equivalent (FTE) growth at each campus. A set of standard space requirements for classrooms, labs, student services, administration and other support space categories is applied to the forecast growth and compared to the existing inventory. Deficiencies in each category are calculated by comparing the existing available space against the state space requirements. The CIP identifies the space needs and addresses the needs in the College priority projects. The CIP is submitted to the Division of Colleges for prioritization along with the other 27 college plans, and a consolidated list is presented to the next Legislature for Public Education Capital Outlay (PECO) funding.

The College's highest priorities in the CIP include remodeling and renovations as follows:

- 1. Nursing Renovations/Remodeling/Expansion: Labs, Simulations Lab, and Support Facilities
- 2. Renovation/Maintenance Public Service Programs: Fire Training Academy of The South (SC), Criminal Justice Center (NC), and Public Safety (SC)

The requirement set forth by the Florida College System is to only present two priority projects annually for consideration. A complete list can be found on the attached CIP-2 Summary document.

The activated program will have new student enrollments beginning with the Spring Term 2024.

The new Specialized Career Education – Comprehensive (900 clock hours) Career Certificate program has been developed to provide individualized job preparatory curriculum for students with significant cognitive/learning disabilities who, in addition to instructional accommodations, require modifications to the Career and Technical Education (CTE) program in order to meet individual interests, abilities and learning needs. The program is individualized for each student and documented in an individualized plan of study (IPS). Instruction is competency-based with integrated academic, technical, and problem-solving skills. The goal is integrated competitive employment in the student's chosen occupation.

The program offers a sequence of courses that provide coherent and rigorous content along with challenging academic standards and relevant technical knowledge and skills needed to prepare students for further education within the Instructional Support Services career cluster. The curriculum provides technical skill proficiency and includes competency-based applied learning that contributes to students' academic knowledge, higher-order reasoning abilities, problem-solving skills, work attitudes, general employability skills, technical skills and occupation-specific skills.

RATIONALE: The College currently offers a Career Certificate in Specialized Career Education Basic (450 clock hours), which is included as part of the FLDOE Instructional Support Services career cluster and will serve as an initial option for students. The Specialized Career Education – Comprehensive (900 clock hours), which includes the first three courses of the basic program, will continue to meet the demand for students with significant cognitive/learning disabilities by providing additional support curriculum options to further enhance their career and educational goals.

BACKGROUND: Rule 6A.10.0331, Florida Administrative Code, requires that institutions inactivate courses that have not been taught for five years. The rule also requires that the identified courses be removed from the college catalog and the Statewide Course Numbering System (SCNS) as part of the ongoing curriculum review process. Institutions must also receive approval for the course inactivations from their respective Boards of Trustees.

When courses are identified for inactivation, faculty and academic administrators receive the opportunity to complete a waiver form for the course purge, thereby maintaining the selected courses in the current, active curriculum inventory.

RATIONALE: Inactivation of courses not scheduled for five or more years will ensure compliance with Rule 6A.10.0331, Florida Administrative Code, resulting in an update (when applicable) to the college catalog and the SCNS for the 2023-2024 academic year.

Subject: Finance: Investment Reports for Quarter Ended March 31, 2023

Meeting Date: June 13, 2023

INFORMATION: The Investment Reports for the Surplus Fund Account (Operating Fund) and the Quasi Endowment Fund for the quarter ending March 31, 2023 are presented to the District Board of Trustees (DBOT) for information.

BACKGROUND: The investment objective of the Operating Fund is to maximize income while minimizing market rate risk, and to insure the availability of short-term liquidity to meet the cash flow needs of the College. Consistent with the DBOT approved Investment Policy Statement, the Operating Fund Portfolio is of high credit quality and invested in U.S. Treasury, Federal Agency/GSE, Federal Agency/CMO, Corporate Note, Asset-backed, Mortgage-backed, Municipal, and Supranational Securities. The Operating Fund Portfolio's quarterly total return performance of 1.54% outperformed the benchmark performance of 1.52%. Over the past year, the Portfolio's total return was 0.49%, compared to 0.20% for the benchmark.

The College utilizes the investment management services of PFM Asset Management LLC (PFM) for intermediate term fixed income investments. As of March 31, 2023, the College had surplus funds of approximately \$35.1 million under management with PFM.

Quasi Endowment Funds are derived largely from auxiliary activities. These funds are also managed by PFM and invested in a diverse portfolio of domestic and international equities, fixed income securities and cash equivalents. The account balance as of March 31, 2023 was \$6.6 million. The Quasi Endowment Fund portfolio (the "Portfolio") returned a gain of 5.78% (net of mutual fund fees) in the 1st Quarter of 2023, underperforming its policy benchmark return of 6.05% by 0.27%. Over the past year, the portfolio had a return of -7.54%, underperforming its -6.43% benchmark return. Since the inception date of July 1, 2016, the portfolio returned 8.26% annually, outperforming its 7.83% benchmark by 0.43% annually. In dollar terms, the portfolio gained \$363,176 in return on investment over the quarter and lost \$542,083 over the past 12-months.

The Investment Performance Review for the quarter ending March 31, 2023 will be available at the District Board of Trustees meeting as information. The report is also reviewed at regular meetings of the District Board of Trustees Finance and Audit Committee.

RATIONALE: The sound investment of surplus funds and endowment funds can produce additional income to support the operations of the College and student financial aid programs while meeting the requirements of safety and liquidity.

FISCAL NOTES: As of March 31, 2023, the College had investment balances totaling \$41.7 million, which compares to \$42.1 million as of March 31, 2022.
