Greetings students,

As we look forward to the beginning of our Fall Term on August 31 and the gradual reopening of certain campus and center classrooms and offices, we wanted to share some important updates:

- The Student Return to Campus Plan will guide you through the measures that are in place to protect the safety and wellbeing of our College community. Important information about required daily selfscreenings (page 3), protective face covering requirements (page 3), available services (page 5) and an understanding of what to do if you develop symptoms of COVID-19 (page 4) can all be found in this plan. Please take the time to review it thoroughly.
- As an added measure to help keep you safe, we have launched a COVID-19 Self-Assessment Tool which will allow all students, faculty and staff to monitor their daily health as they prepare to come onto campus. The assessment tool can be found within the ESCJ Safe mobile app. All students, faculty and staff are encouraged to use this tool to answer a short series of questions before visiting one of our campuses, centers or offices, as your responses will create personalized guidance to help you decide whether or not you should. If you are unable to use the tool, the daily self-screening can be completed by following these steps.
- You should also review the <u>Getting Back to Campus website</u> for additional information regarding the phased-in return approach, policies and procedures, helpful resources and the latest information on Fall Term classes. Currently we are in <u>Phase 2</u> of our reopening plan, which means we are prepared to meet our students' high priority needs with limited onsite staffing, working within public health guidelines.
- All on-campus student services are available online, including Academic Advising, Tutoring, Disability Services and more. You can access these services through the <u>Student COVID-19 Resources page</u>, or by calling the Contact Center at (904) 646-2300 or by email at <u>welcome@fscj.edu</u>. Certain on-campus services will be available on a limited basis beginning with the Fall Term. These services include: Advising, Success Coaches, Student Financial Services, computer labs in campus Library and Learning Commons and Assessment Centers to administer

standardized exams that require examinees. Course exams will continue to operate through remote proctoring.

- If you have received a positive test result for COVID-19, please fill out this brief online form. If you need assistance, please call (904) 633-8233 and a representative from FSCJ will help you. Be prepared to leave your name and phone number if you are prompted to leave a message so that a representative can call you back. NOTE: If you receive a positive test result, please do not come to campus. We value your confidentiality; at **no** time will your identity be shared as part of our contact tracing process.
- Continue to check your FSCJ student email regularly for the latest information and updates. You should also download the <u>FSCJ Safe</u> <u>App</u> for timely alerts.
