Your application was selected for review in a process called "Verification." In this process, FSCJ will compare information from your 2016-17 Free Application for Federal Student Aid (FAFSA) with copies of your 2015 IRS Tax Return Transcripts, and/or W-2 forms and/or other financial documents. Information retrieved using the Internal Revenue Service (IRS) Data Retrieval Process and not subsequently changed, is considered acceptable documentation for IRS-related information. The law requires us to ask for this information before awarding federal aid. If there are differences between your application information and your financial documents, FSCJ will need to make corrections.

You are required to complete all appropriate sections of this form and submit it to FSCJ with any additional requested documentation. If you do not complete this form or submit all of the required documents requested, we will not be able to complete the processing of your financial aid.

## What You Should Do:

- 1. Check your Connections checklist for requested documents. Collect and submit requested documents.
- 2. If you did not retrieve and transfer you (and your spouse's, if married), and/or your parent(s)' income tax return information using the IRS Data Retrieval Process when initially completing the FAFSA, you can request to transfer this information to your FAFSA now by going to <a href="fafsa.ed.gov">fafsa.ed.gov</a>. Once you complete the transfer, if the information retrieved was not changed, the 2015 IRS Tax Return Transcript requirement for you (and your spouse, if married) and/or your parent(s) will be waived. Check your Connections checklist to see if this document requirement has been waived.
- 3. Complete, sign and submit this worksheet and the requested 2015 IRS Tax Return Transcripts, along with any other requested worksheets and documents to FSCJ. Be sure to include your name and Student ID at the top of each document.
