- 2. Bidders are to utilized the Attachment "E" REPLACEMENT Solicitation Drawing Pages: C0.1, C0.2, D1.1, D1.2, D1.3, C1.1, C1.2, C1.3 and C5.1 included with the Addendum #1 for construction and bidding purposes.
- 3. Safety barrier fence will need to be installed where indicated on the drawings providing a line of demarcation to faculty, staff, students and public for the planned limits of construction. Locations designated for vehicular and/or pedestrian access must be manned during active construction to direct safe activities.

QUESTIONS AND ANSWERS

- 1. Q: The BID FORM lists three (3) Base Bid line items. Base Bid #1: North Campus Delivery Service Drives Base Bid #2: North Campus Criminal Justice Center (CJC) Driving Course Base Bid #3: North Campus Criminal Justice Center (CJC) Skills Pad Aprons However, the drawings do not clearly indicate what areas are included in each of these Base Bids. Please clearly identify each area as soon as possible to meet Bid Deadline.
 - A: Base Bid #1 is scope of work indicated on Drawings D1.3 & C1.3. Base Bid #2 is scope of work indicated on Drawings D1.2 & C1.2 plus the driving course loop indicated at match line on Drawings D1.1 & C1.1. Base Bid #3 is scope of work indicated on Drawings D1.1 & C1.1 less the driving course loop indicated at match line.
- **2. Q:** Is the 25% M/WBE participation a goal or is it mandatory?
 - A: No, it is a GOAL to achieve for State Reporting of MBE's usage.
- 3. Q: Who does the M/WBE need to be certified through (i.e. FDOT, COJ, State of FL...)?
