CLARIFICATIONS

- 1. <u>The Question Deadline Date has expired.</u>
- 2. Bidder are to note that Submittal document Section 5.90 Lots 3, 4, 5, 7, and lot 8 item description is "38 cutting annually" but the quantity is "36 ea". Each Campus lot location, at their discretion may add additional cutting at the proposed per cutting cost.

QUESTIONS AND ANSWERS

- Q1) North campus. The viburnum hedges have not been included in the last bids urrounding the baseball field. Are they included as part of the 2025c bid.
- A1) As the College's needs have changed since the previous Solicitation (FSCJ RFP 2019C-17) issued 7-years ago in January of 2019, the current solicitation (FSCJ RFP 2025C-17) is addressing those College-wide changes of services needed. Yes, as stated under Section 4.05, GENERAL SCOPE FOR ALL CAMPUS / CENTERS, Paragraph E, Hedge Maintenance, which states: "All hedge plants will be undercut below established heights and borders to promote new growth and filling hollow areas. After hedge plants re-establish themselves with new growth, trimming will .be done to keep plants within the boundaries identified."
- Q2) Is there a Zone Count for Irrigation for each Campus? While visiting, I could not find any irrigation for any of the locations for each campus
- A2) This should be confirmed by the contractor during site visit with Campus Facilities Director and/or Center Facilities Supervisor after the award of contract. Refer to Addendum #2 Questions & Answers "Note"
- Q3) Please confirm that there are turf treatments included at each campus as there wasn't any evidence of any at most of the locations
- A3) Only North Campus courtyards and ball fields at North.
- Q4) South Campus Does the EMT Academy on the corner need to be serviced on the weekends like the Fire Academy?
- A4) The EMT Academy (Bldg. P) is considered a part of the Fire Academy of the South location. However, the EMT Building P property can be completed during normal working hours.
- Q5) South Campus Is the ROW included in front of the Fire Academy and The ROW that connects the Fire Academy around to the South Main Campus?
- A5) COJ and JEA has grounds maintenance outside fence. Grounds maintenance within fence shall be by this contractor.
- Q6) Cecil Center-Aviation-Are the Vacant lots included along the streets New World Avenue, Skillside Street, Crossover Street, and the parking lot in front of Aerospace Way?
- A6) Vacant lots are not in contract.
- Q7) Cecil Center-Truck-Are the ROW a reas included a long Fingerlake Street, POW Memorial Avenue, and Normany Blvd? Is the new building (Early College Learning) Included?
- A7) Not in contract, maintained by City of Jacksonville or San Hose Early College.
- Q8) Kent Campus-Is the Median on Roosevelt included that runs along the campus per map?
- A8) This contract will maintain along Roosevelt between the side walk and East Perimeter Road on FSCJ property.
- Q9) Deerwood Campus-What is the scope and expectation of the Parking Garage?
- A9) This contract will maintain palm trees and shrubs located between garage and building entrance and grass along garage perimeter.
- Q10) Nassau Campus What is the scope for the Cabins in the woods between campus and climbing wall facility per map?
- A10) The scope is included as defined in Addendum #2.
- Q11) Downtown Campus- Are the ROW areas outside of the black iron fence included along First Street, State Street, Broad Street,

Laura Street, (Outer Perimeter)?

A11) Yes, grounds maintained to back of curb.

- Q12) Downtown Campus Is building AO and Parking lot 10 included behind Cancer Survivors Park Included (Mapshows NO but not sure)
- A12) Yes, it is included.
- Q13) North Campus Are the middle medians along Capper Street Included?
- A13) No, Maintained by City of Jacksonville.
- Q14) Please confirm the frequency of retention pond service. Some say 38 occurrences, some say quarterly.
- A14) Retention pond serviced monthly by Florida Waterways under separate contract with FSCJ.
- Q15) Will this be awarded to a single provider, or multiple?
- A15) As stated in the RFP 2025C-16 Solicitation Document, Section 3.00 Problem Statement/RFP Objectives, Paragraph 3.03: <u>"</u>The College intends to evaluate/award new contract(s) to commence on or about August 1, 2025. The College reserves the right to award a contract to a single contractor or to multiple contractors as deemed in the best interest of the College."
- Q16) Please confirm that monthly irrigation inspections are to be included. Please clarify what is expected in communication / forms for these checks.
- A16) Yes, inspection reports shall be provided monthly as evidence of monthly inspections.
- Q17) Please confirm that ALL trees and ALL shrubs at ALL locations are to receive dormant insecticidal spray once annually.
- A17) Yes
- Q18) Please confirm that all flower beds (of which we found none) are to be included at the same maintenance rate (38) of all ornamental landscape beds in regards to maintenance assuming that some are built and planted. Industry standard is once a month for flower beds.
- A18) Flower beds maintenance rate should be once a month.
- Q19) North campus Requesting clarification if the hedges are included around the ballfield as they have been excluded from previous bids.
- A19) Maintained by other vendors under separate contract to FSCJ.
- Q20) North Campus the large triangle area to the East is not on the campus map where all the large Oaks are located. Is this part of the 2025 bid. It was included in the 2019 bid.
- A20) Yes, included in this scope. Refer to "Attachment D" of this addendum.
- Q21) Please confirm if the minority participation of 19% is required, or is an optional goal.
- A21) Minority participation of 19% is NOT a requirement, but a goal of the College for each awarded contract.
- Q22) Kent campus Please clarify Leaf and debris will be 36 services during cycle visits or 52 as it states removal to be done weekly year-round page 26 of lot 9.
- A22) Leaf and debris services to be done during cycle visits. However, each Campus lot location, at their discretion may add additional leaf and debris services at the proposed perservices cost as additional services.
- Q23) Can the current contract for this bid be provided?
- A23) As the College's needs have changed since the previous Solicitation (FSCJ RFP 2019C-17) awarded contracts issued 7-years ago in January of 2019, the contract(s) generated off the current solicitation (FSCJ RFP 2025C-16) is addressing those College-wide changes of services needed.
- Q24) Can the previous bid tab for this contract be provided?
- A24) Yes, refer to Attachment "C" RFP 2019C-17 Posted Tabulation Sheet which was Publicly posted from 3/23/2019 through 3/28/2019.
- Q25) Can you please confirm for the retention pond and drainage ditch mowing that contractors are only to mow within 18" to 24" from the edges of ditches and ponds for the base contract and for the Alternate 7-line item it is supposed to reflect the

remaining 18" to 24"?

A25) Yes.

- Q26) Can you please confirm an estimated a creage for the Bushhogging-Field Alternate 10 and for the Bushhogging-Under brushing Alternate 11?
- A26) Assume 5 acres at Cecil North. Not in contract for balance of campus-center locations.
- Q27) Which areas at North Campus are included in the Bush hogging Underbrush line?
- A27) No bush hogging. Currently mowed.
- Q28) How many pounds per 1,000 sqft are contractors to apply Rye seed at?
- A28) Only at North Campus baseball fields.
- Q29) Can you please confirm what specific area the butterflygarden area is? Based on the pricing sheet Alternate 14 does not seem to be included.
- A29) Not to be included in contract.
- Q30) Please confirm that the power line easement between South Campus and the Fire Academy is not included in this bid.
- A30) Not in contract, maintained by JEA.
- Q31) Can you please confirm that the maps provided in Addendum 2 for Cecil Center are accurate and contractors should only perform services within the yellow lines?
- A31) Maps show general location of FSCJ maintained areas. Contractors should visit site and discuss limits with Center Facilities Supervisor and/or Campus Facilities Director.
- Q32) For North Campus, can you please confirm which areas on the walking trailare contractors to apply pine straw and herbicides? Is this the area around the pond by the walking trail?
- A32) Yes, walking trail is campus wide. FSCJ will evaluate whether to maintain or to be abandoned.
- Q33) How many inches thick should contractors apply pine straw mulch for the walking trail at North Campus?
- A33) Provide minimum two inches thick.
- Q34) Is the minority participation a requirement for this bid? If so, please confirm the goal is only 19%?
- A34) Minority participation of 19% is NOT a requirement, but a goal of the College for each awarded contract.
- Q35) Will contractors be allowed contract escalations, based on the Consumer Price Index, each renewal year?

A35) Yes, As stated in the RFP 2025C-16 Solicitation Document, Section 3.00 Problem Statement/RFP Objectives, Paragraph 3.011, which states; "It is the College's intention that the resultant contract(s), if approved by the District Board of Trustees at their June 10, 2025 board meeting, would be for an initial contract period of August 1, 2025 through July 31, 2026 with up to five (5) optional one (1) year extension termed periods. Renewal of each term would be subject to satisfactory performance, continued need, mutually agreeable rates, same terms and conditions, continued receipt of adequate appropriations by the State of Florida Legislature, and District Board of Trustee approval of extension."

Each Contract Renewal Response to the College's Request to Renew Letter; will need to identify Renewal (as Yes, With Consideration of Cost Increase). The following documentation will need to be submitted for the Renewal with the Increase Request: (1) require a Written request of increase, (2) itemized prices and percentage of increase requesting (in the Contract Pricing Format) Excel Spreadsheet and (3) Justification of increase (Example Consumer Price Index.)

- Q36) Does the clause in section 1.02 mean that the maximum that can be awarded to one contractor is \$195,000 per year? In 2.05 it is stated that two (2) firms were awarded six (6) years ago at \$199,000.
- A36) Yes, each contract awarded from Solicitation RFP 2025C-16 will be awarded as stated in Section 3.00, Problem Statement/RFP Objectives, Paragraph 3.012, which stated; "The anticipated contract(s) shall have a maximum per funded purchase order (job/project) issuance not to exceed \$195,000 with a maximum capped term period expenditure of \$600,000."
- Q37) Can a list of specific licenses that are required be provided to all bidders?
- A37) As Stated in Solicitation Document RFP 2025C-16 Section 4.00 Proposal Guidelines/Scope of Services, Paragraph 4.04 (4.046) which states; "Maintain all required licensures authorizing work of this scope as listed in RFP #2025C-16 Submittal Document

Section 5.1020." Note that the Scope of Work includes Chemical Applications.

- Q38) How many total irrigation controllers, and individual irrigation zones, are there at each location which is required to be maintained?
- A38) Refer to the Answer of Question 2.
- Q39) For ant control, should this be achieved by broadcast applications of bait or spot treatment of ant mounds as they occur or both?
- A39) FSCJ is responsible for ant control on campus.
- Q40) Will Insecticides, Fungicides, Herbicides and Fertilize under the Additive Alternate items be applied to turf areas, bed areas, or both?
- A40) Both.
- Q41) Will soil tests only be required once per year?
- A41) Yes.
- Q42) Please provide the total palm tree count, per location.
- A42) To be verified by Contractor based on site visit.
- Q43) What species of sod should be price for Additive Alternate 13?
- A43) Bahia and Bermuda (Ball fields and interior courtyards).
- Q44) What size plant material should be installed for the annuals?
- A44) Reference Addendum #2 for plant material size 18 count boxes.
- Q45) What on-center spacings hould be used at installation of the annuals?
- A45) To be determined by FSCJ with contractor input based on contractor's unit pricing.
