NOTICE TO LICENSED GENERAL AND ROOFING CONTRACTORS:

Florida State College at Jacksonville (here in after referred to as the “College”, “Owner” or “FSCJ”) is soliciting bids for select demolition of the existing built-up roof over sloped lightweight insulated concrete with internal roof drains. Provide new roof membrane system installed per current NRCA and Florida Building Code 2023, 8th edition. The existing roof contains an existing lightning protection system which will need to be removed, re-installed and re-certified. Existing roof mounted equipment and exhaust vents will remain in place with new flashing assembly at base curbs as well as guy wire supports as needed. Scope of work defined per plans and specifications prepared by TTV Architect, Inc. dated 2/2/2024. Roof Moisture Evaluation Services Report generated by Terracon Consultants, Inc.: Report #F9236200 dated 10/5/2023 titled “South Campus Building G – Library/Commons & Building Q – Fitness Center.” This project is being funded through the State of Florida Department of Education from the Federal American Rescue Plan (ARP) Act of 2021, Coronavirus State Fiscal Recovery Fund – Deferred Maintenance Program which requires compliance of Federal 2 CFR Part 200.
