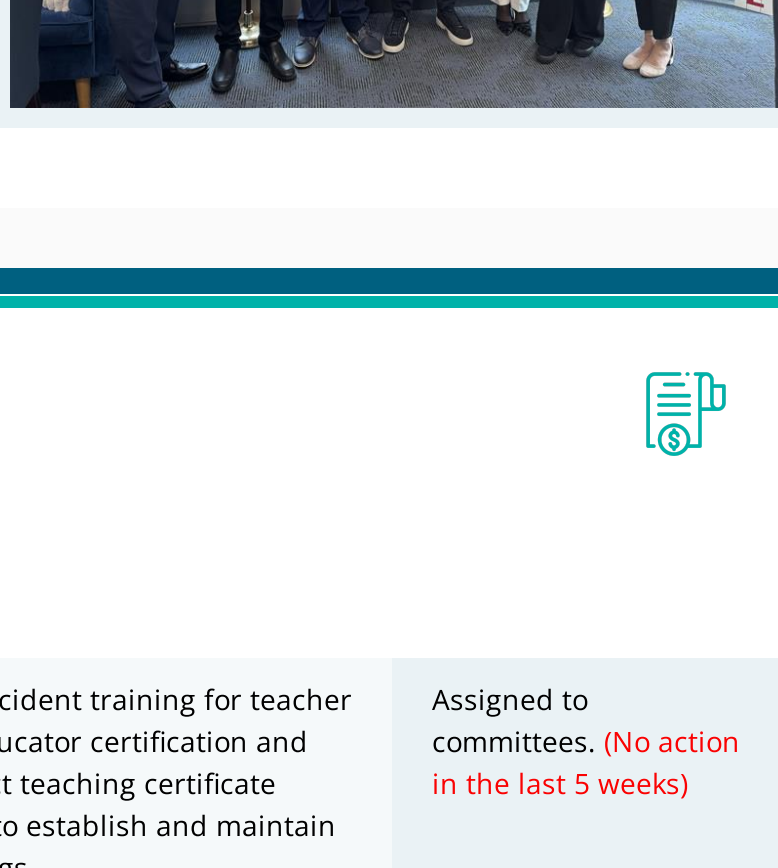

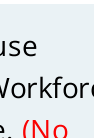
## Legislative Update - Week 5
