Benefits Open Enrollment



Benefits Open Enrollment for 2024 will be held October 16 through October 27. During this time, employees can make changes to their insurance plan elections to include adding or removing dependents. The Benefits team will be available on each campus during the first week of Open Enrollment to assist with enrollment elections. Watch for information on the changes to the health insurance plans, 2024 premium rates, and vendor information in the upcoming weeks.

Leave for Hurricane Closure

With the College closure due to Hurricane Idalia, Benefits removed all leave requests submitted and previously approved for Tuesday, August 29 through Wednesday, August 30. Supervisors should deny any pending leave requests for the College closure period. The "College Closure" absence event entry for each full-time employee is an administrative action taken by FSCJ to track the financial cost of Hurricane Idalia and does not affect the employee's absence balance(s). For all full-time, <u>non-exempt</u> employees (those who complete a timesheet) identified as essential staff and thus worked during the College closure, please continue to enter actual hours worked on the respective timesheet. Then, fill out a Straight Time Pay (STP) Form and submit it to <u>payroll@fscj.edu</u> for processing. Please contact <u>payroll@fscj.edu</u> for any questions about timesheets or completing an STP form.

Salary Increase

The District Board of Trustees (DBOT) recently approved a 3.5% salary increase with a minimum of \$1,000 for all eligible full-time non-instructional employees and a 3.5% salary increase for part-time non-instructional Administrative, Professional, Career, and designated part-time employees. These pay increases are effective September 1, 2023, and will be reflected on the September 23 paycheck.

Additionally, the Board approved an increase to the adjunct Work Load Unit (WLU) rate to \$700 per WLU and the adjunct timesheet hourly rates for clock-hour programs to \$30/hr. Adjunct pay increases are effective as of August 28, 2023.

The College administration and faculty union continue their interest-based bargaining including compensation.

College Holidays and Non-Operational Days

The Board recently approved an extension to the 2023 Winter Break, adjusting the start date to Wednesday, December 20, 2023. This extension will increase the break by three days, from December 20-31.

Employees are not required to request leave (and supervisors should not approve absence requests submitted) for College Holidays and non-operational days. Employees who have leave requests previously submitted and approved for dates in which the College is closed due to a holiday, an extensionday, or non-operational day should cancel those requests to prevent an impact on their absence balances.

NEW - FSCJ Succession Planning Program

The **FSCJ Succession Planning Program** is a year-long program that will provide individualized professional development opportunities designed to prepare employees for critical positions within the institution. While participation in the succession planning program <u>does not guarantee</u> that an employee will advance into a specific position, it will provide the employee with opportunities to enhance their competencies, skills, and experience.

The Executive Leadership Team has approved the following critical positions for the 2023-2024 year:

- <u>Associate Provost, Curriculum and Instruction</u>
- <u>Associate Vice President, Enrollment Management & Student Success</u>
- Chief Human Resource Officer

All FSCJ employees are eligible to apply. Interested participants must complete the Succession Planning Application Form. 2 - 7 employees per position will be selected to participate in the program. Approval up through the employee's chain of command to the Vice President is required and will be obtained through an electronic workflow. **Succession Planning applications and approvals are due Friday, September 15**.

Florida Minimum Wage Increase

Effective September 30, 2023, the state of Florida is raising its minimum wage from \$11.00 to \$12.00 per hour.

Exit Process for Employees

Employees should familiarize themselves with the procedures regarding their separation from the College. The employee's supervisor will complete an electronic Clearance Form prior to the employee's last working day to ensure compliance with this policy in order for the terminal leave payout to be processed by HR.
