## myIMPACT Reminders

Supervisors will receive a notification in March to complete the Check-in task in mylMPACT for Professional and Career employees. Check-ins are meetings between supervisor and employee regarding the employee's performance progress, individual development plan and goals.

A series of question prompts is provided as a guide to facilitate conversation between the supervisor and employee, but conversations are not limited to these prompts. Check-in dates and any comments should be recorded in the space provided.

# **Faculty Evaluations**

Faculty are evaluated according to the guidelines established in <a href="Article 11">Article 11</a> of the Collective <a href="Bargaining Agreement">Bargaining Agreement</a>. Specifically, faculty on annual contracts are to be evaluated once per year with first-year faculty being evaluated during their second teaching term. Absences Entered in myFSCJ by Supervisors

Supervisors should enter absence requests on behalf of an employee in myFSCJ if the employee is not able to do so. Once entered, edits to that entry can only be completed by the supervisor.

## **Training and Organizational Development**

### **CRRSA Professional Development Program Reminder**

Full-time faculty and staff who have not yet completed the total 40 hours of professional development are still eligible to complete the remaining hours for a combined maximum payout of \$2000 (\$50 per hour). Employees will receive a total equal to the number of hours completed, up to the maximum of 40 hours. For example, if an employee completes 10 hours, the employee will receive \$500.
