

About the Program

The Technical Certificate (T.C.) in American Sign Language focuses on the development of ASL skills for practical application, an introduction to Deaf culture, and a fundamental awareness of the profession of sign language interpreting. Completion of this program expands a student's communication skills, diversity awareness, and ability to support inclusive environments professionally and personally.

Course content is relevant to professionals who serve members of the Deaf community in industries such as human resources, education, social services, healthcare, emergency services, and mental health.

This certificate does not prepare students to become sign language interpreters.

Program Requirements

This program requires a minimum of 22 credit hours. Total program hours may vary based on the student's individual academic plan. This program is not eligible for financial aid.

Prior experience with American Sign Language is not required for admission to this program. Students who have prior experience with American Sign Language are recommended to contact the program at interpreting@fscj.edu for an ASL placement screening. Students who place into a higher course than ASL 1140 or ASL 1150 may select from a combination of courses to meet the minimum credit hours required for this certificate.

Students in this program are not required to complete math courses unless they are listed as part of the certificate program. If you plan to pursue the degree program in this same field, please note This certificate articulates directly into the ASL/English Interpreting (221A) (A.S.) degree, which includes a **Mathematical Thinking in Context math pathway**. Placement Testing

College placement testing assesses incoming students' skill levels in English, mathematics, and reading. Students are exempt from placement testing if they meet any of the following conditions:

- Entered the ninth grade in a Florida public school in 2003 or after and graduated from a Florida Public High school with a standard high school diploma
- Are currently serving as an active-duty member of any branch of the U.S. Armed Services
- Have received an A.A., A.S., A.A.S. or higher from an accredited institution
- Have completed college-level courses in English and mathematics
- · Have completed upper-level developmental courses in English/Reading and Mathematics
- Are a Transient student (Florida Shines or transient letter from home institution is required)

All other students in this program must take a placement test. Students who place into **developmental education courses** are required to complete designated developmental education courses with a grade of C or higher regardless of program of study and are also required to take one of two student success strategies courses. Technical Certificate Graduation Requirements

Fulfill all academic requirements for the chosen program of study as outlined in the Florida State College at Jacksonville catalog and curriculum.
Earn minimum prescribed semester hours for the chosen program of study with a cumulative grade point average of 2.0 (C) on a 4.0 scale on all courses that apply to the chosen program of study.
Complete a minimum of 25 percent of the total hours required for the program in residence at Florida State College at Jacksonville. Credit by examination and credit for prior learning do not count toward this residency requirement.
Fulfill all obligations, financial or otherwise, to the College before graduating.

Educational Pathways

This certificate articulates directly into the ASL/English Interpreting (A.S.) degree. You may pursue one or more certificates to develop or upgrade your skills in a particular field or pursue the A.S. degree and earn technical certificates while completing the requirements for the degree. Catalog Year

This document is prepared for students with a 2025-26 College Catalog year who have not tested into developmental education courses. Students who enter under the 2025-26 catalog will be assigned to the degree or certificate requirements in effect during the 2025-26 academic year. The student's assigned catalog year will remain in effect as long as the student maintains continuous enrollment. Changes to requirements as mandated by law or by rule of the District Board of Trustees may supersede this provision.

To maintain continuous enrollment, a student must have registration for, and successful completion of, at least one course within a three-term period. After three consecutive terms of no enrollment, the student will be discontinued from the current program of study and will need to apply to FSCJ to reenter under the same program of study. Upon readmission, the student will be assigned to the current catalog of record in the chosen program.

Conditions: This course can be taken by students not enrolled in the ASL/English Interpreting program to satisfy associate in arts elective credits and/or foreign language requirements. ASL 1221 - American Sign Language V, Credit Hours: 3. Prerequisite(s): ASL 1210 with a grade of C or higher. Corequisite(s): None. Conditions: None. Terms Offered: Fall.

ASL 1300 - Linguistics of American Sign Language, Credit Hours: 3. Prerequisite(s): Qualify for enrollment in ENC 1101 or ENC 1101C and ASL 1150 with a grade of C or better or Permission from the Dean. Corequisite(s): None. Conditions: This course can be taken by students not enrolled in the ASL/English Interpreting program to satisfy associate in arts elective credits and/or foreign language requirements. Terms Offered: Spring.

ASL 1430 - Fingerspelling and Numbering, Credit Hours: 2. Prerequisite(s): ASL 1150 with a grade of C or higher or permission of the Dean. Corequisite(s): None. Conditions: This course can be taken by students not enrolled in the ASL/English Interpreting program to satisfy associate in arts elective credits requirements. Terms Offered: Summer (alternates w/ ASL 1930).

ASL 1930 - Special Topics in American Sign Language, Credit Hours: 2. Prerequisite(s): ASL 1150 with a grade of C or higher. Corequisite(s): None. Conditions: This course may be repeated up to 3 times for credit. Terms Offered: Summer (alternates w/ ASL 1430).

ASL 2510 - Deaf Culture, Credit Hours: 3. Prerequisite(s): None. Corequisite(s): None. Conditions: This course can be taken by students not enrolled in the ASL/English Interpreting program to satisfy associate in arts elective credits and/or foreign language requirements. Terms Offered: Fall.
